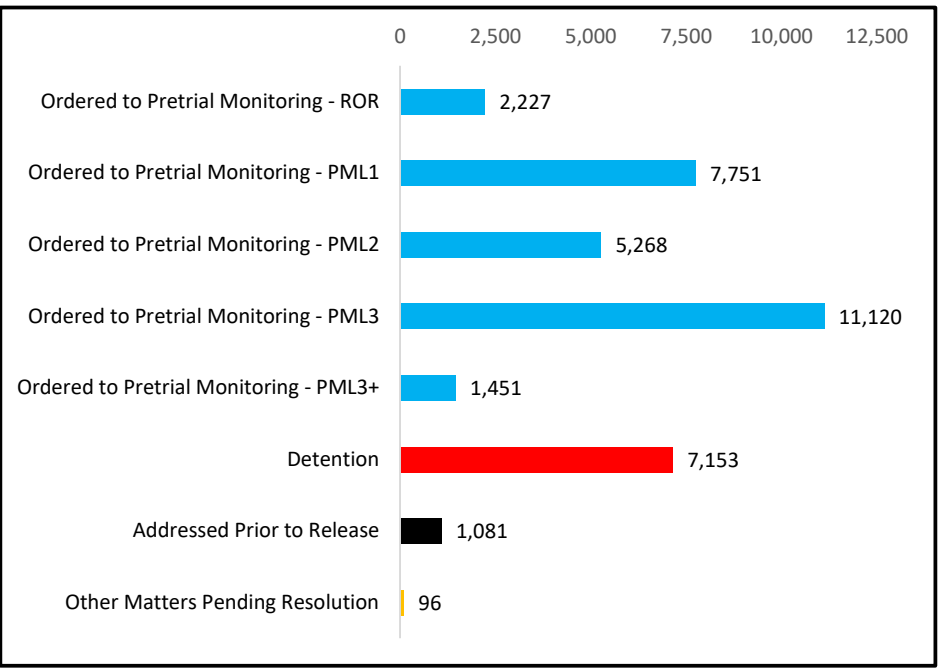

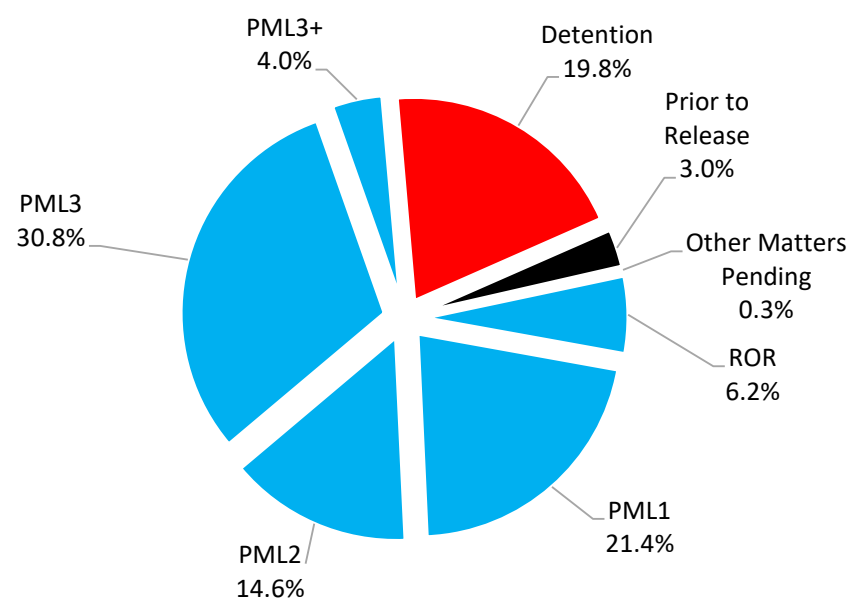

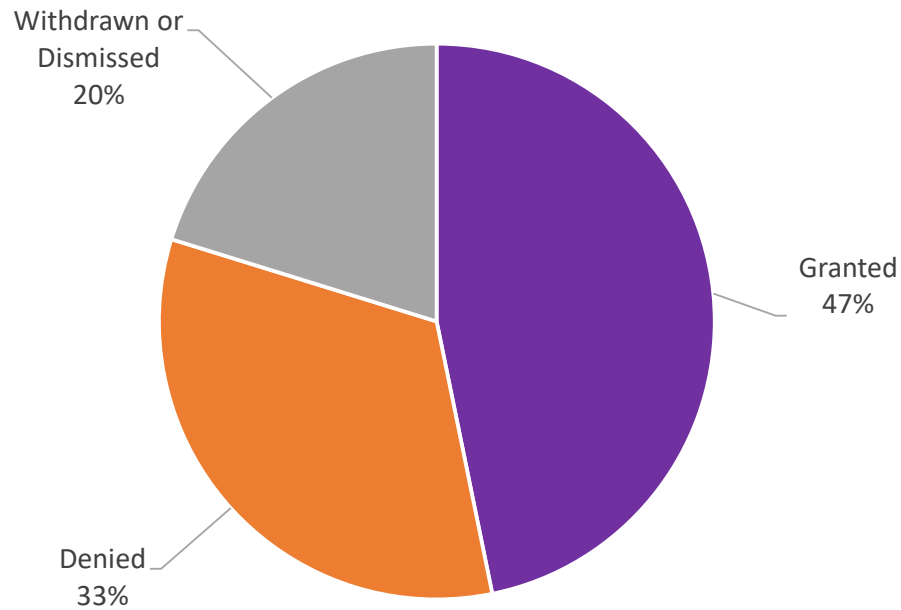

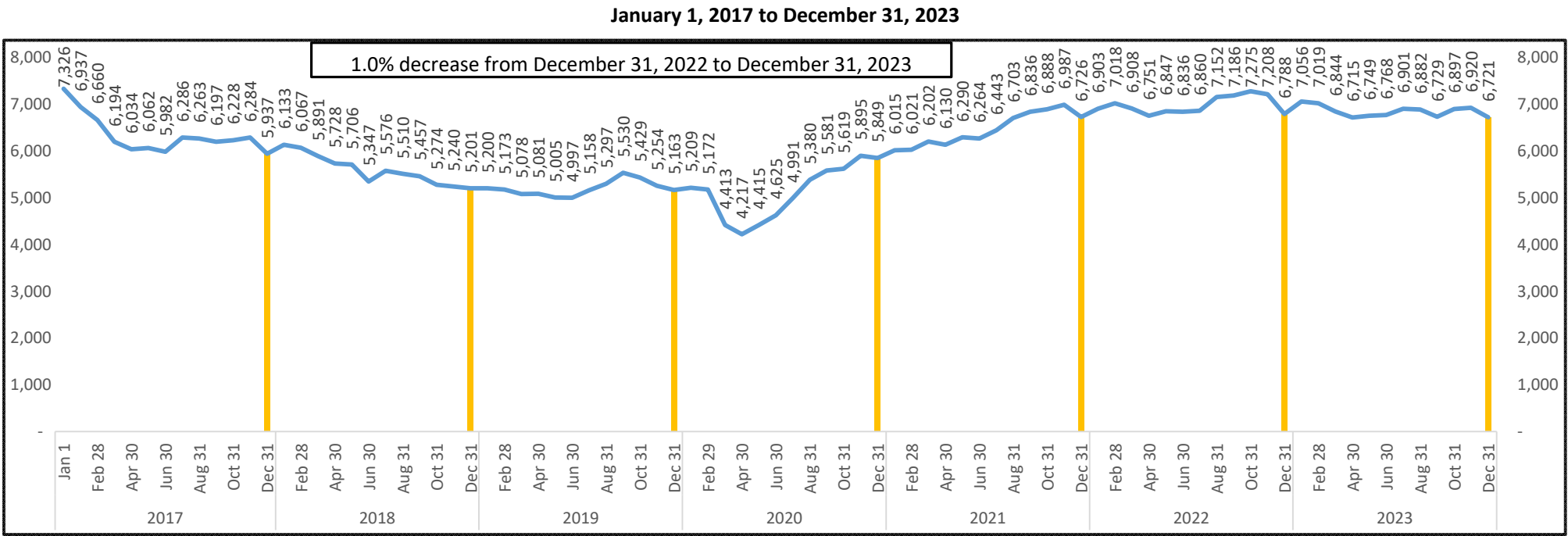
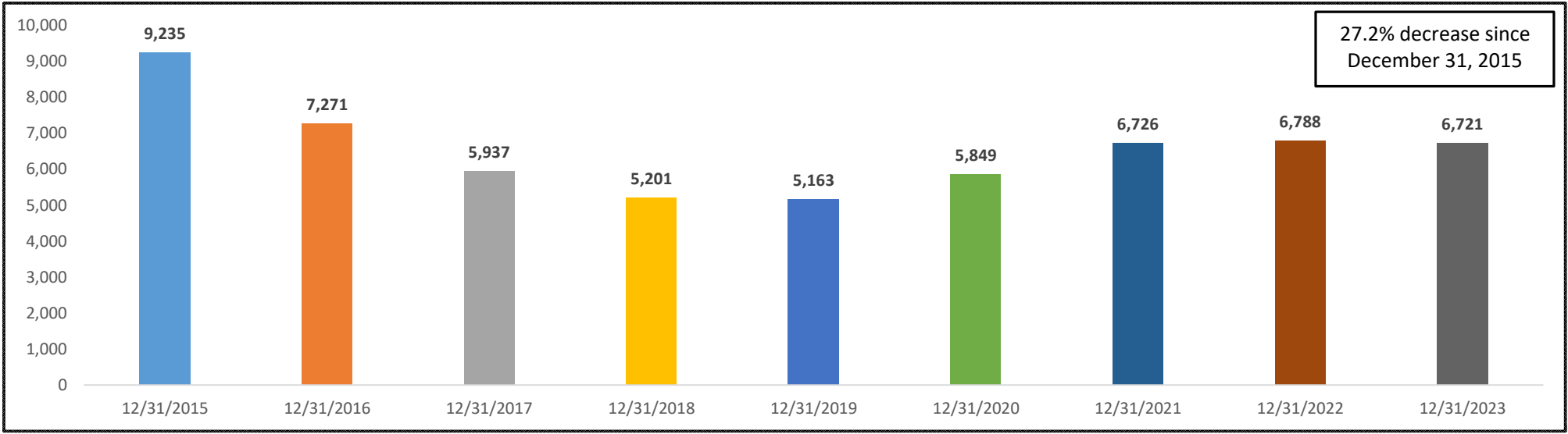

 December 31, 2015 and December 31, 2016 -2023



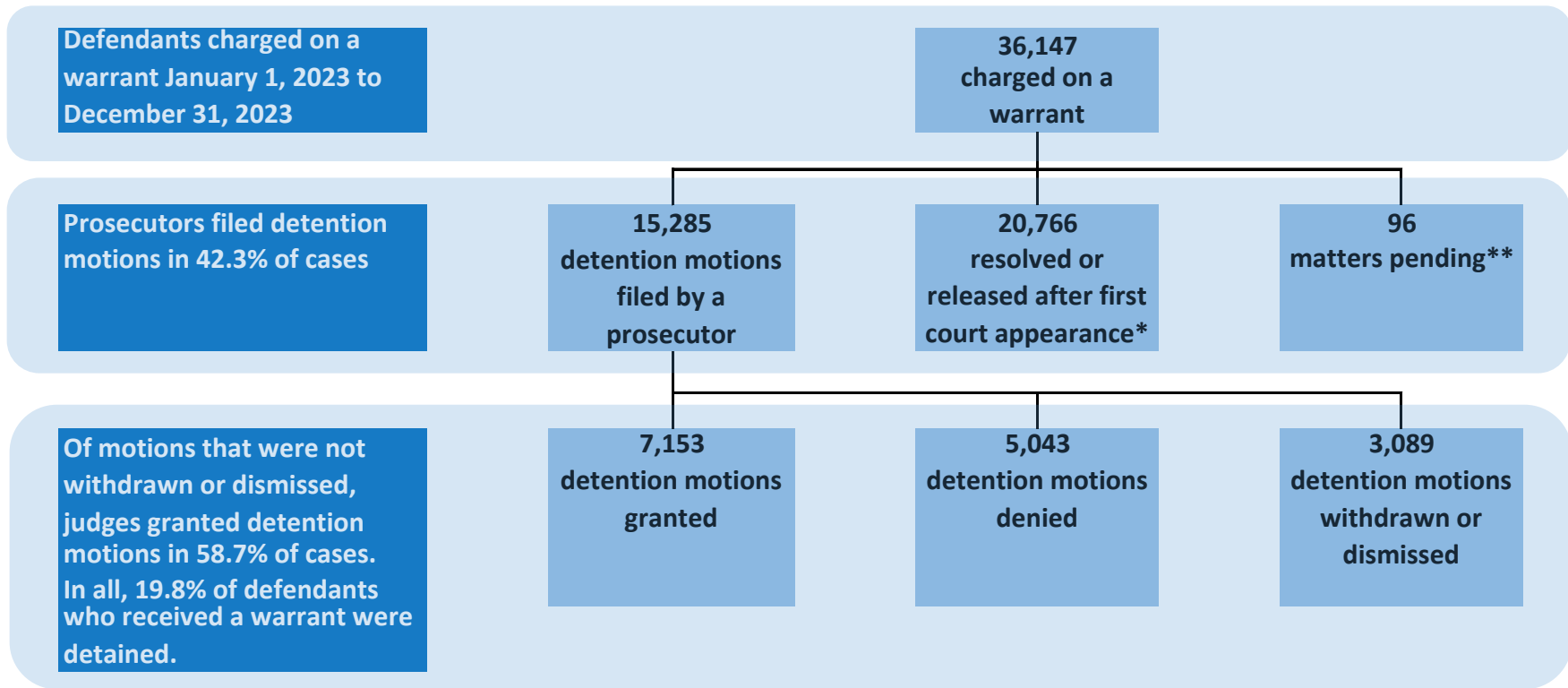

### Pretrial Detention Decisions

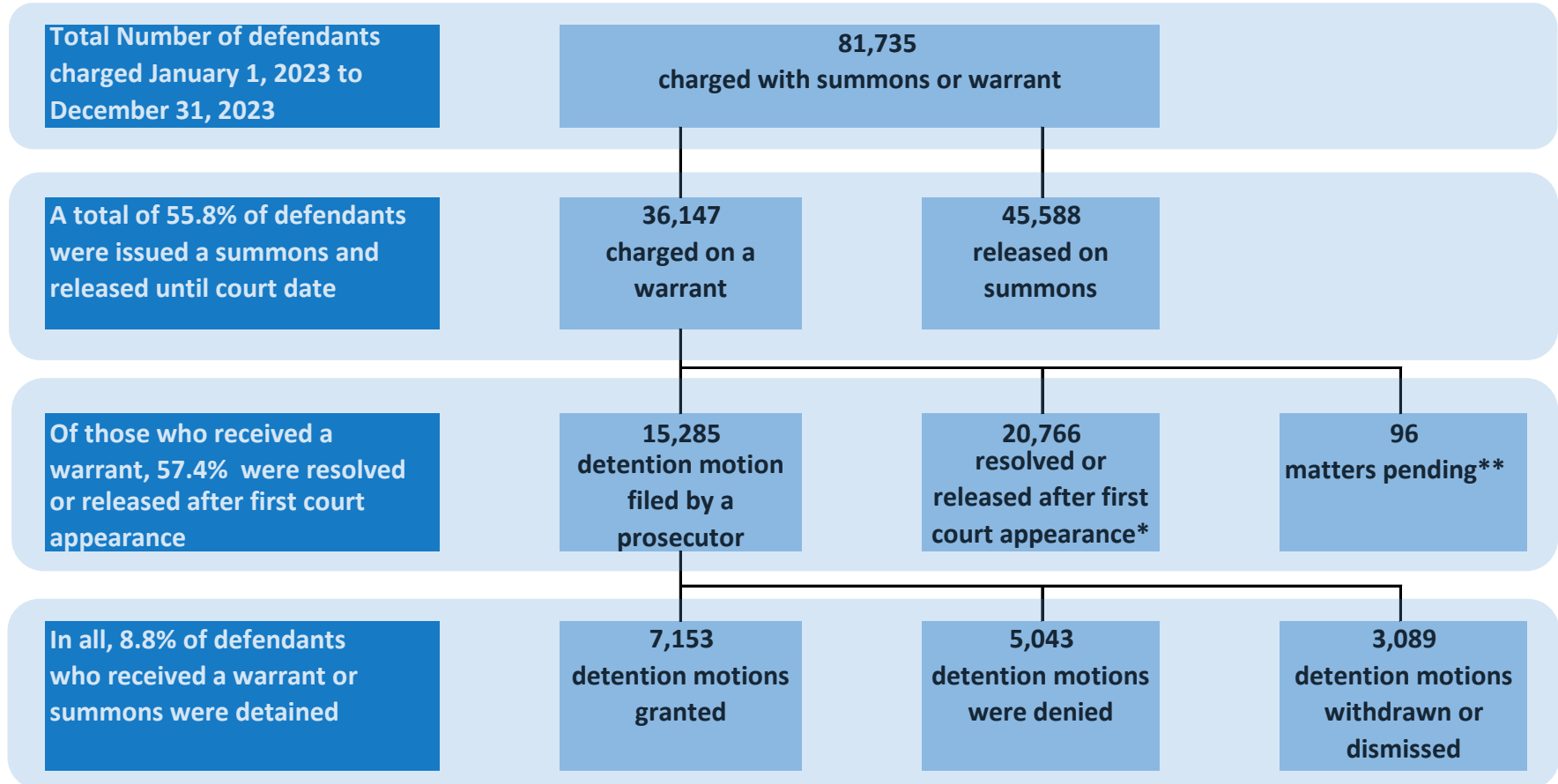
January 1, 2023 - December 31, 2023
