IT IS on this 15<sup>th</sup> day of August, 2018,


ORDERED that this matter is now DISMISSED WITH PREJUDICE for the following reasons:

1. This Court's 7/10/18 Order Compelling Substitution of the Estate of Mary Dean Pursuant to R. 4:34-1(b) required that the Administrator of the Estate of Mary Dean appear before this Court by 7/20/18 with Letters of Administration and substitute himself or herself as the party-in-interest in this case.
2. All interested parties served with the Motion to Compel Substitution of the Estate of Mary Dean and the 7/10/18 Order were those listed in Plaintiff's PFS, which was prepared by Gary Pasquale and plaintiff's former counsel Kline & Specter, P.C. Kline & Specter, P.C. was also served with the Motion to Compel and the 7/10/18 Order. The individuals listed in Plaintiff's PFS were Roy Dean (plaintiff's husband), alleged administrator Gary Pasquale, Michael Dean, Deborah Pasquale, Denise Calcagno, and Darlene Frank.
3. These individuals had a sufficient amount of time to comply with this Court's 7/10/18 Order and simply failed to come forward and present Letters of

Administration declaring him or her the Administrator of Plaintiff's Estate.

IT IS FURTHER ORDERED that a "filed" copy of this Order be served upon opposing counsel within seven (7) days of the date hereof.
