

ORDERED that all claims, cross-claims and third party claims between the parties be


and are hereby dismissed with prejudice. The parties shall bear their own fees and costs.

**ORDERED** that copies of this Order shall be served upon all counsel of record and all liaison counsel within five (5) days of the date hereof.


