ORDER OF JUDGMENT

Defendants.

THIS MATTER having been tried before the Honorable Rachelle L. Harz, J.S.C. and a jury; and the jury having rendered a verdict on December 14, 2017; and for the reasons set forth on the record and for good cause shown;

IT IS on this 1st day of June, 2018;

ORDERED as follows:

1. Judgment in the amount of \$4,877,312.42 (\$4,014,000.00 plus prejudgment interest in the amount of \$863,312.42) is hereby entered in favor of plaintiff Elizabeth Hrymoc, jointly and severally against defendants Johnson & Johnson and Ethicon, Inc. for compensatory damages.

2. Judgment in the amount of \$1,215,075.34 (\$1,000,000.00 plus prejudgment interest in the amount of \$215,075.34) is hereby entered in favor of plaintiff Tadeusz Hrymoc, jointly and severally against defendants Johnson & Johnson and Ethicon, Inc. to compensate Tadeusz Hrymoc for loss of consortium.

3. Judgment in the amount of \$10,000,000.00 is hereby entered in favor of plaintiffs jointly and severally against defendants Johnson & Johnson and Ethicon, Inc. for punitive damages.

4. The compensatory verdict calculations are calculated with pre-judgment interest through December 14, 2017. Post-judgment interest shall accrue on the compensatory damage awards from that date forward. Post-judgment interest on the punitive damages award shall commence from the date of the December 14, 2017 punitive damage verdict.

5. Taxed costs to be entered by the Clerk are hereby awarded to plaintiffs as per the New Jersey Court Rules.

6. A copy of this Order of Judgment shall be served by plaintiffs' counsel on defendants' counsel within seven (7) days of the date hereof.
