**ORDER FOR ADMISSION OF COUNSEL *PRO HAC VICE***

This matter being opened to the court by James Tracy, Esquire, a New Jersey attorney and the attorney of record for Plaintiff, Beryl McClure to permit Jasper D. Ward, Esq., an attorney admitted to practice law in the State of Kentucky, to participate with other counsel for Plaintiff, Beryl McClure in all phases of the trial, and it appearing that Jasper D. Ward, Esq. is a

licensed attorney in good standing in the State of Kentucky, and it appearing that Plaintiff, Beryl McClure has requested he represent them as Jasper D. Ward, Esq. specializes in mass tort, medical device and

pelvic mesh litigation, a complex field of law and which is the subject of this litigation.

It is on this 16 day of Dec., 2013, ORDERED that Jasper D. Ward, be and hereby is admitted *pro hac vice* and is authorized to appear and participate with other counsel for Plaintiff, Beryl McClure, in all phases of the trial, subject to the following conditions:

1. Jasper D. Ward shall abide by the *New Jersey Court Rules* including all disciplinary rules, *R. 1:20-1* and *R. 1:28-2*.

2. Jasper D. Ward shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon whom service of process may be made for all actions against Jasper D. Ward that may arise out of his participation in the matter.

3. Jasper D. Ward shall immediately notify the court of any matter affecting his standing at the Bar of any other jurisdiction.


4. Jasper D. Ward shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. Jasper D. Ward must, within ten (10) days, pay the fees required by *R. 1:20-1(b)* and *R. 1:28-2* and submit an affidavit of compliance.

6. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by *R. 1:20-1(b)* and *R. 1:28-2*.

7. Non-compliance with any of the terms of this order shall constitute grounds for removal.

8. A copy of this order shall be served on all parties within seven (7) days of the date hereof.
