JOINT STIPULATION AND ORDER

The Plaintiffs' Steering Committee and Defendants Alaven Pharmaceutical LLC and Meda Pharmaceuticals Inc. ("Alaven") entered into a master settlement agreement in August 2015 ("Master Settlement Agreement") with the intention of resolving, inter alia, all claims asserted against Alaven in this proceeding. Those plaintiffs who have thus far agreed to settle with Alaven (the "Settling Plaintiffs") are listed in Exhibit 1 to this Joint Stipulation and Order. A corresponding Order of Disposition for those Settling Plaintiffs is annexed hereto as Exhibit 2.

As a result of this agreement to settle, Alaven and counsel for each Settling Plaintiff hereby stipulate as follows:

1. Each and every Settling Plaintiff has uploaded a Notice of Intent to Enroll in the Reglan Settlement Program to the BrownGreer PLC Settlement Administration Portal. (See attached Notice of Intent to Enroll Form as Exhibit 3.)
2. By submitting the Notice of Intent to Enroll, each Settling Plaintiff has agreed to enroll in the Reglan Settlement Program and be bound by the terms of the Master Settlement Agreement of Alaven Pharmaceutical LLC and Meda Pharmaceuticals Inc. and settle all claims asserted against Alaven Pharmaceutical LLC and Meda Pharmaceuticals Inc. In furtherance of the Settling Plaintiffs' agreement to settle all claims asserted against Alaven, Alaven and the undersigned counsel agree that all claims asserted against Alaven by or on behalf of the Settling Plaintiffs are hereby dismissed with prejudice, with each side to bear its own costs and fees in

accordance with the Settlement and Release Agreement referenced in the MSA ("Release").

3. In addition to the Notice of Intent to Enroll each and every Settling Plaintiff has agreed to fully and properly execute a Release of claims against Alaven and its insurers. Such Release, as provided in paragraph 5 below, must be submitted through the BrownGreer PLC Settlement Administration Portal for review and approval by Alaven.
4. By this Joint Stipulation and Order, and in exchange for the dismissal of each Settling Plaintiffs claims against Alaven with prejudice referenced in Paragraph 2 above, Alaven agrees it will deposit the final settlement funds into the Qualified Settlement Fund within sixty (60) days after entry of this Joint Stipulation and Order in all three of the coordinated Reglan/metoclopramide proceedings in California (Case No. CJC -10-004631), Pennsylvania (Case No. 100101997) and New Jersey (Case No. 289) in which the majority of claims by or on behalf of plaintiffs who have thus far agreed to settle with Alaven are pending against Alaven. For the avoidance of doubt, this Joint Stipulation and Order is not intended to vary any of the other terms of the Master Settlement Agreement.
5. BrownGreer PLC may disburse the allocated settlement funds to a Settling Plaintiff only upon Alaven's approval of that Settling Plaintiff's Release and supporting documentation¹ through the BrownGreer PLC Settlement Administration Portal. This includes those Releases that have already been approved by Alaven prior to the entry of this Joint Stipulation and Order.
6. For those Settling Plaintiffs whose Releases have already been approved by Alaven, it is anticipated that they will receive their settlement payment from BrownGreer PLC within thirty (30) days from the date Alaven deposits the final settlement funds into the Qualified Settlement Fund. For those Settling Plaintiffs

¹ Supporting documentation shall mean any documentation that shows the Release was signed by a person with authority to do so including, but not limited to, Guardian ad Litem forms, Minors Compromise, Joint Stipulation and Agreement re Deceased Plaintiffs, Sworn Statement of Representative Claimant, Will and Testament, Letters of Administration, and /or other proof of representative capacity

who have not yet uploaded Releases or whose Releases have not yet been approved by Alaven, following Alaven's deposit of the final settlement funds into the Qualified Settlement Fund, it is anticipated that a Settling Plaintiff will receive his/her settlement payment from BrownGreer PLC within thirty (30) days from the date Alaven approves that Settling Plaintiff's Release and supporting documentation.

7. Pursuant to this Joint Stipulation and Order and the Notice of Intent to Enroll in the settlement, the only remedy or recourse for Settling Plaintiffs to resolve their individual claims against Alaven shall be the funds that Alaven deposits into the Qualified Settlement Fund under the Master Settlement Agreement (as set forth in Paragraph 4 herein). Further, as a result of entering into this Joint Stipulation and Order, no further action against Alaven concerning the subject matter of this proceeding may be brought by any Settling Plaintiff, heir of a deceased claimant, minor, minor's guardian or Settling Plaintiff's lawyer.


IT IS SO STIPULATED

Now therefore:

1. Pursuant to this Joint Stipulation and Order and the accompanying Order of Disposition, it is Ordered that all claims asserted against Alaven, by or on behalf of the Settling Plaintiffs listed in Exhibit 1 to this Joint Stipulation and Order, are hereby dismissed with prejudice, with each side to bear its own costs and fees in accordance with the Release; and
2. Pursuant to this Joint Stipulation and Order it is hereby Ordered that the only remedy or recourse for Settling Plaintiffs to resolve their individual claims against Alaven are the funds that Alaven deposits into the Qualified Settlement Fund under the Master Settlement Agreement.
