THIS MATTER, having come before the Court at a case management conference on August 26, 2020 and counsel for Plaintiffs and counsel for Defendants having been present, and for good cause having been shown;

IT IS on this 2 day of ~~September~~ 2020, ORDERED as follows:

**1. MOTIONS TO REINSTATE FILED WITHOUT SERVICE UPON DEFENDANTS**

- Plaintiffs' counsel will consent to vacate any Orders entered for those Motions to Reinstatement that were filed, not served upon Defendants and granted by the Court as unopposed and that Defendants identifies it intends to oppose.
- Within a reasonable time period following the Court's decision on Plaintiffs' pending Motions for Reconsideration of CMO 8 and Motions for Reconsideration for failure to comply with multiple PFS and/or proof of use related Orders, Defense counsel will identify those cases for which the reinstatement order shall be vacated, draft the order(s) to vacate and coordinate submission of such order(s) to the court.
- Thereafter, Plaintiff's counsel may refile the motion(s) to reinstate with proper service upon Defense Counsel.

**2. AUTHORIZATIONS**

- Pursuant to the broad discovery provided pursuant to R. 4:10-2, Plaintiffs shall grant Defense Counsel permission to add medical providers to the general authorization unless there is a specifically identified objection concerning privilege as permitted by R. 4:10-2.

- Plaintiff's failure to recognize a medical provider does not constitute a sufficient objection.

**3. AMENDED COMPLAINTS FILED FOLLOWING BIFURCATION OF MULTI-PLAINTIFF COMPLAINTS.**

- McKesson will file Answers to the Amended Complaints identified in Exhibit A pursuant to the schedule identified therein.
- Should plaintiff serve additional Amended Complaints upon McKesson not identified in Exhibit A, McKesson shall negotiate and submit a supplemental CMO concerning their responsive pleading schedule.

**4. DECEASED PLAINTIFFS**

- Plaintiff's counsel shall not file complaints on behalf of a deceased plaintiff unless filed through an estate representative.
- The following cases identified in Exhibit B are hereby dismissed with prejudice since the complaint was filed after the plaintiff was deceased and therefore the deceased plaintiff did not have standing to file the complaint.
- If Plaintiffs' counsel has proof that the plaintiff was not deceased at the time the complaint was filed, they may file a motion for reconsideration of the dismissal on that basis only.
- Plaintiff's counsel may seek to file a new complaint through an estate representative.

**5. COMPLAINTS ASSERTING A CLAIM FOR LOSS OF CONSORTIUM WITHOUT AN IDENTIFIED SPOUSE.**

- Plaintiffs' counsel shall file corrected Amended Complaints by September 9, 2020 for those cases identified in Exhibit C.
- The corrected Amended Complaint shall identify a spouse if a Loss of Consortium claim is asserted and shall identify the spouse as a party in the caption of the Amended Complaint.
- The Amended Complaint shall be served upon Defense counsel as follows:

**6. CERTIFICATIONS OF COUNSEL REGARDING PLAINTIFF CERTIFICATION ALTERATIONS.**

- Plaintiff's counsel shall provide a certification to Defense Counsel which specifically identifies and delineates counsel's authority to change the date of Plaintiff's certification of the Plaintiff Fact Sheet. The certification of counsel shall specifically confirm that plaintiff has reviewed and certified the document contents and has authorized counsel to update or change the date of a previously submitted certification.

**7. E-COURT SUBMISSIONS**

- Counsel shall submit the Case Management Conference Agendas and Case Management Conference Orders via e-courts.

**8. UPDATED CASE LIST**

**EXHIBIT A - DEFENDANT MCKESSON  
CORPORATION'S ANSWERS TO  
BIFURCATED PLAINTIFFS' AMENDED  
SHORT FORM COMPLAINTS**

Defendant McKesson Corporation (“McKesson”) shall file Answers on a rolling basis on or before December 21, 2020, to the Amended Short Form Complaints that plaintiffs served on McKesson on August 18, 2020, August 19, 2020, August 24, 2020, and August 26, 2020, bifurcated from one of the cases listed below, subject to the following exceptions:<sup>1</sup>

- For cases in which a motion to reinstate is pending, McKesson shall file answers to these amended complaints 20 days after the court’s order granting reinstatement or by December 21, 2020, whichever is later. No answers to such amended complaints shall be required unless the Court orders reinstatement.
- For both amendments to original complaints and newly filed bifurcated complaints, McKesson shall not file answers to complaints naming a deceased plaintiff until 20 days after the order granting plaintiff’s motion to amend the caption to include the estate or by

<sup>1</sup> On August 18, 2020 plaintiffs filed their motion to amend and bifurcate the Evelyn Jackson case (MID-L-6037-18). McKesson will attempt to file answers to the complaints bifurcated from this case, subject to the exceptions contained in this document, within 35 days of service or by December 21, 2020, whichever is later. If additional time is required, McKesson will meet and confer with plaintiffs to discuss a mutually agreeable schedule for McKesson’s answers.

December 21, 2020, whichever is later, or 35 days after a newly filed complaint on behalf of the estate is filed and served or by December 21, 2020, whichever is later.

- McKesson shall not file answers to complaints filed for cases currently dismissed unless an order is granted reinstating that case. If the case is reinstated, an answer shall be filed 20 days after the order granting reinstatement or by December 21, 2020, whichever is later.
- McKesson shall not file answers to complaints alleging a loss of consortium claim which names only one plaintiff until 20 days after plaintiffs serve the amended complaint with the additional spouse named as a party and identified in the caption or by December 21, 2020, whichever is later.
