

How To Watch a Live Virtual Courtroom First Appearance Broadcast

First appearance hearings conducted in Superior Court are streamed LIVE from various locations around the state for the public to view on a computer, tablet or smartphone, generally during non-business hours. During normal business hours (Monday – Friday) you can watch a first appearance hearing in the county courthouse. When first appearances are held on weekends, holidays, or during scheduled or unscheduled closings, the hearings may be available on the NJ Courts website. Check the locations on our website for when and how to watch the proceedings in each county.

1. To view the live stream of a Virtual Courtroom first appearance hearing, **launch a browser** (i.e.: Internet Explorer, Edge, Safari, Chrome) and enter the following address: www.njcourts.gov/vc
2. Locate the time and details of the first appearance hearing you are interested in by clicking on the (>) next to the county name. Click the link “Click here to watch”.




