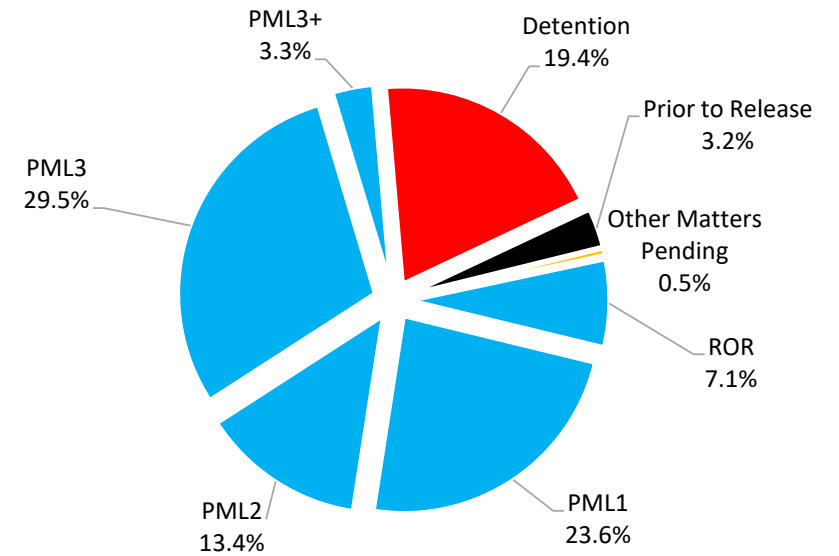

**Initial Release Decisions by Type of Decision (number of defendants)**



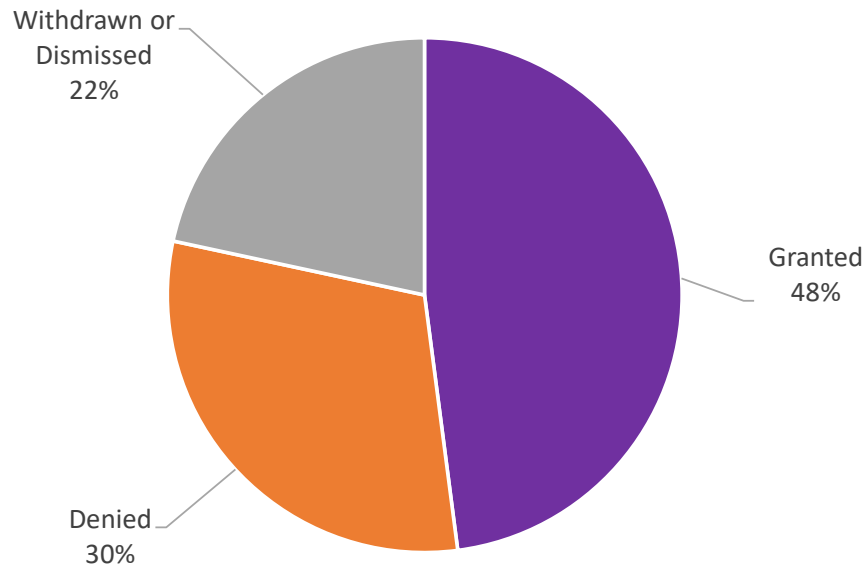
**Initial Release Decisions by Type of Decision (percentage of defendants)**

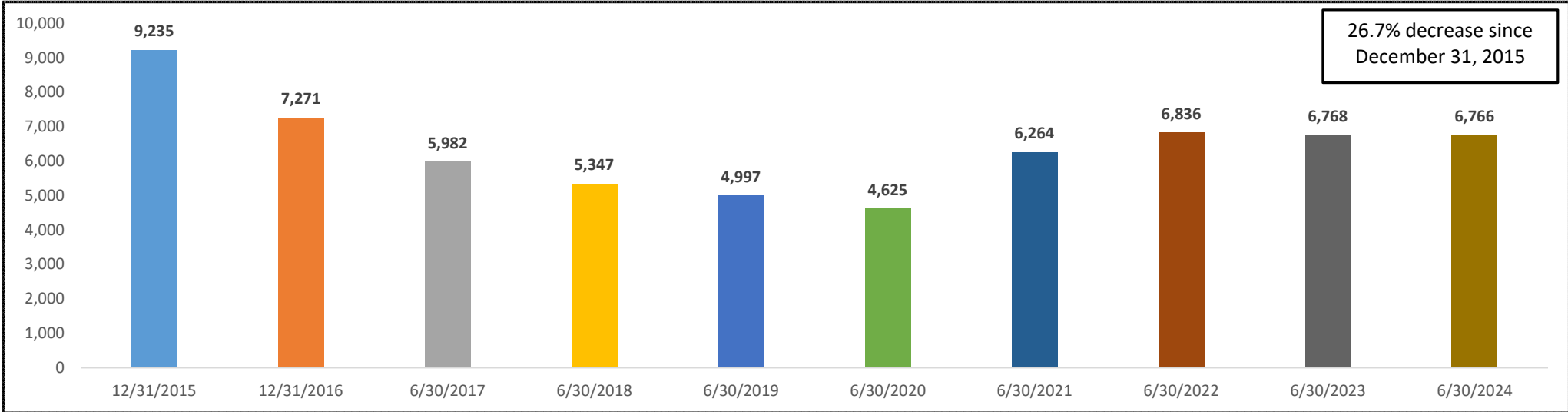

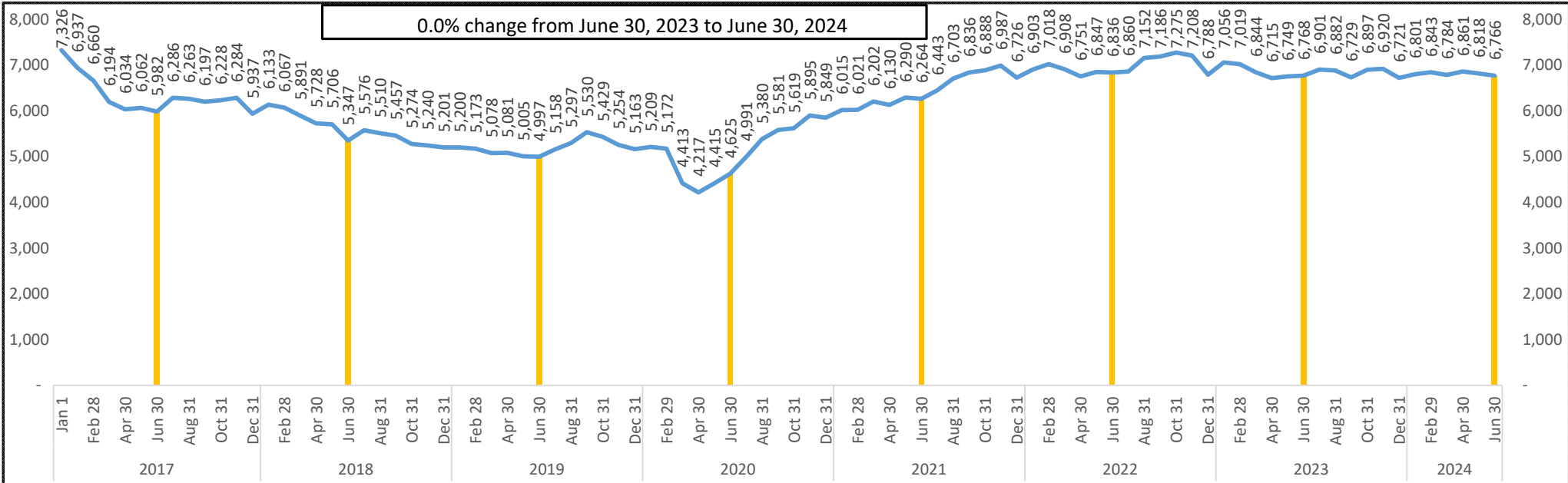

Nonsentenced Pretrial Jail Population



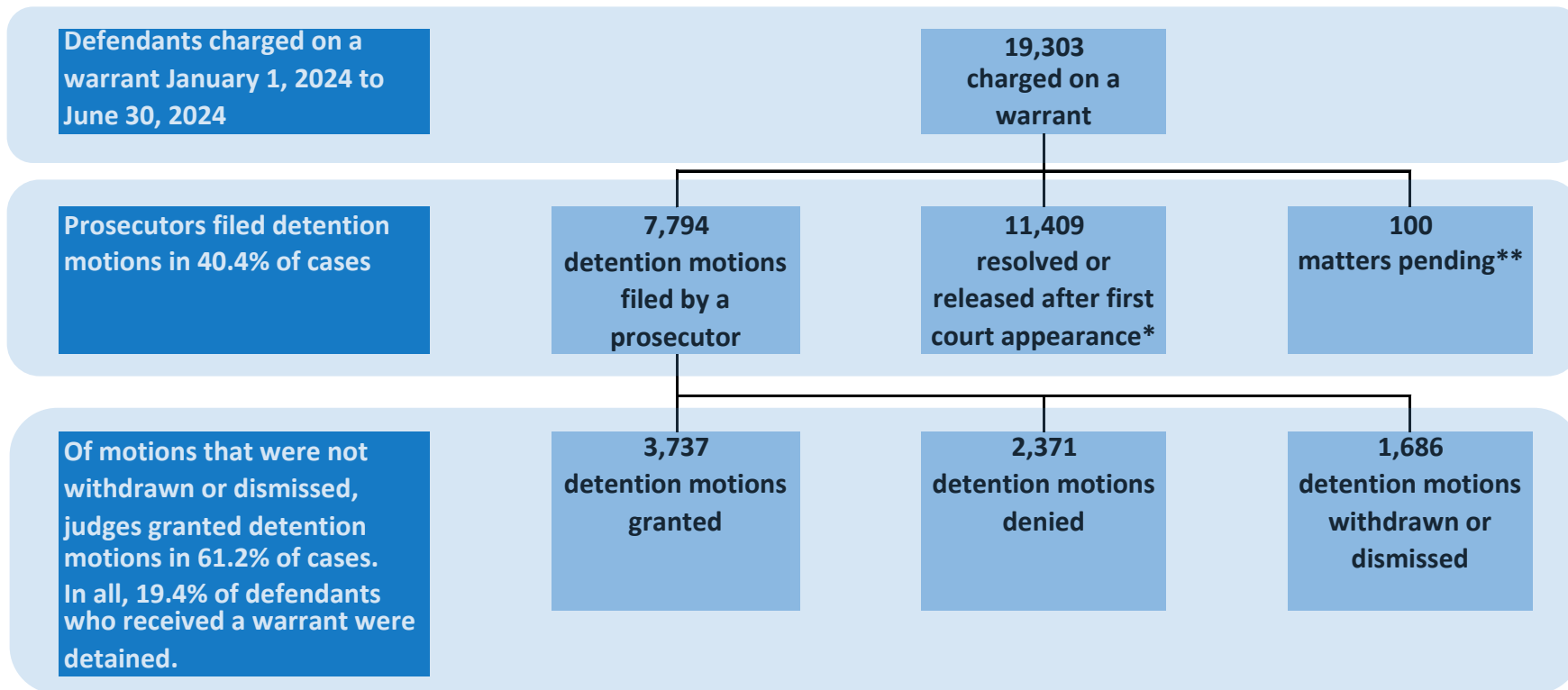
January 1, 2017 to June 30, 2024

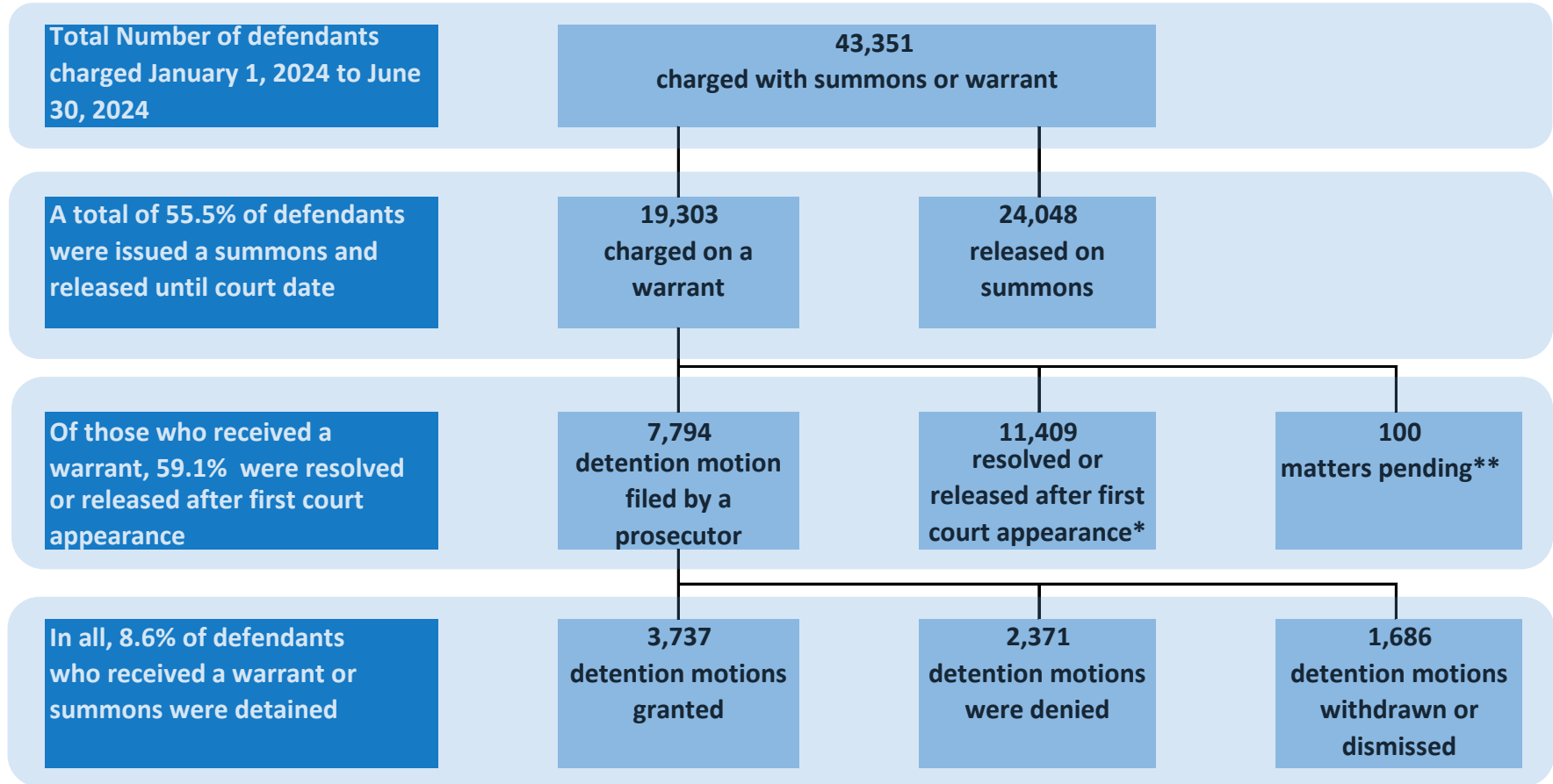
## Chart D (Warrant) Pretrial Detention Decisions January 1, 2024 - June 30, 2024
