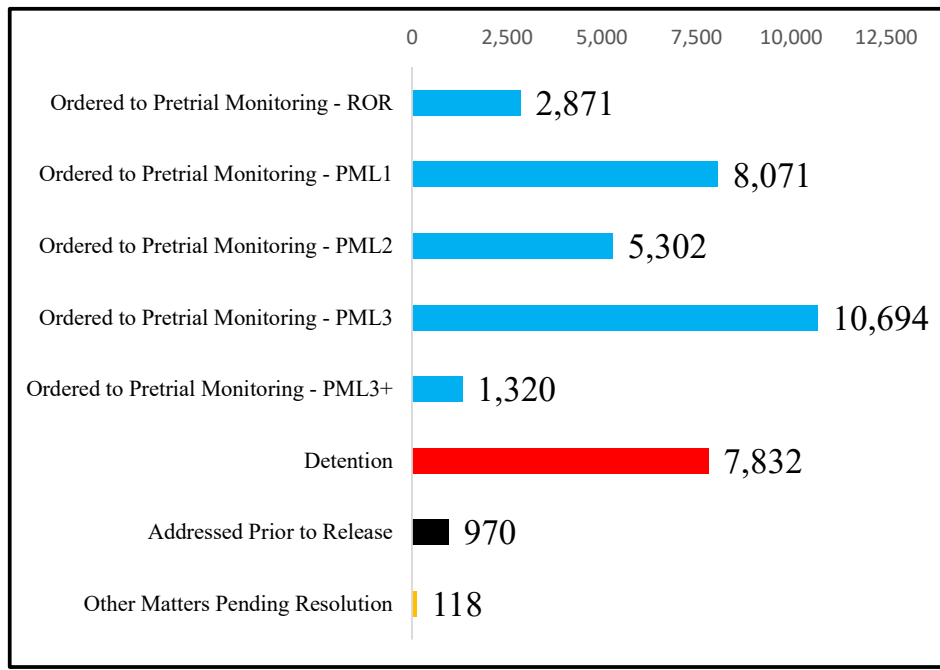

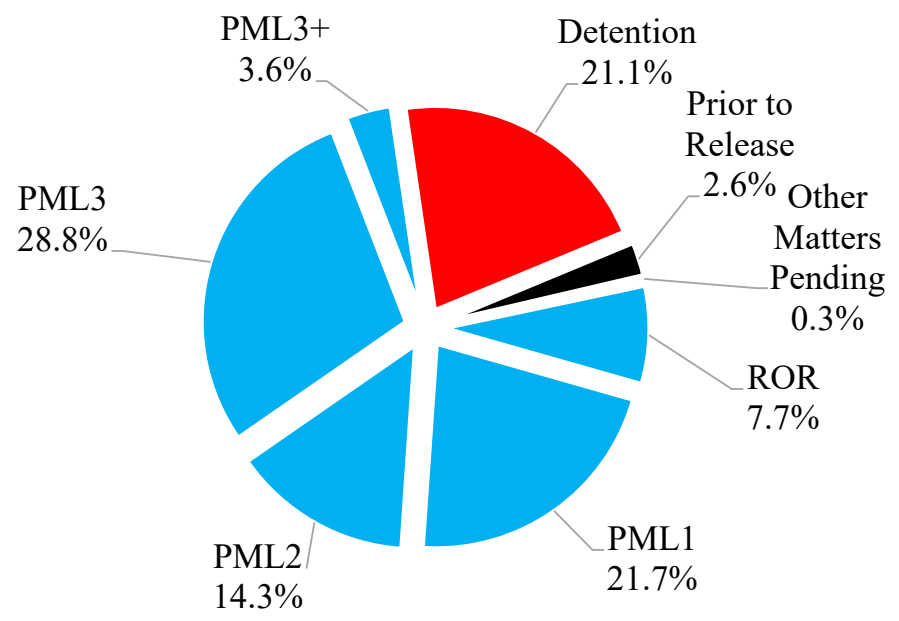

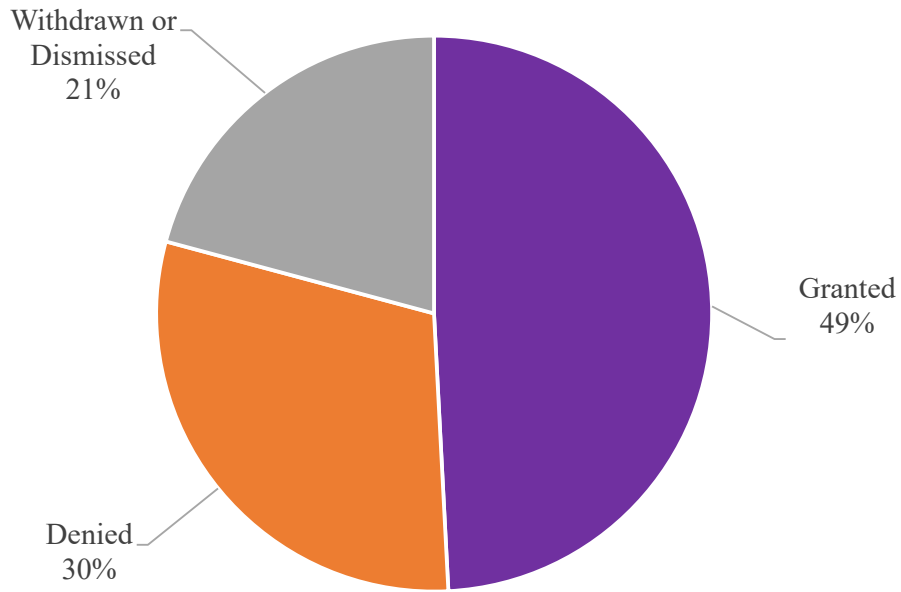

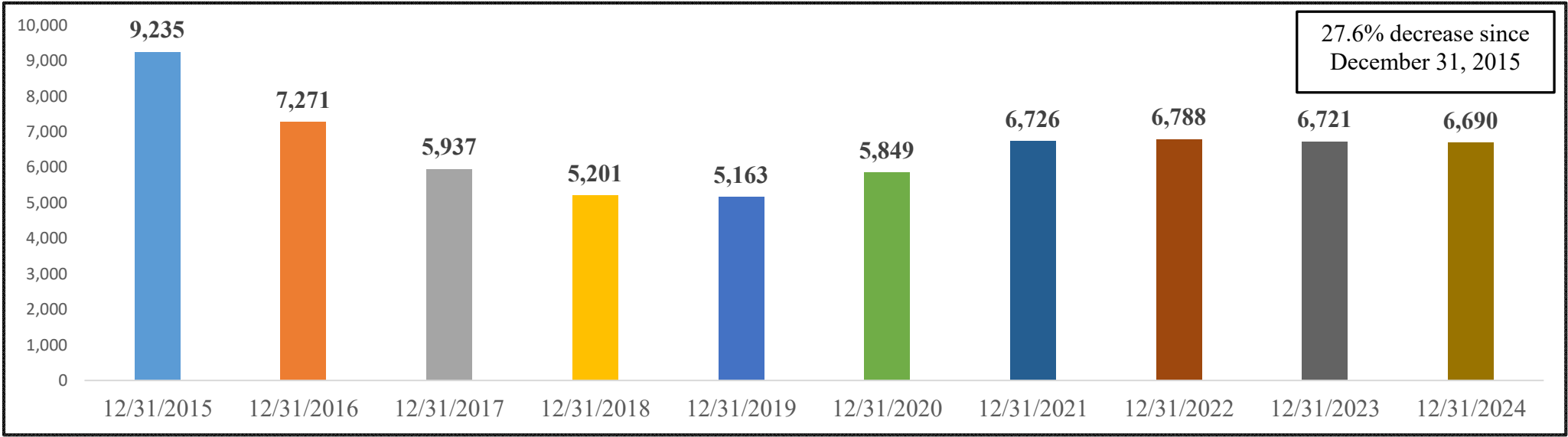

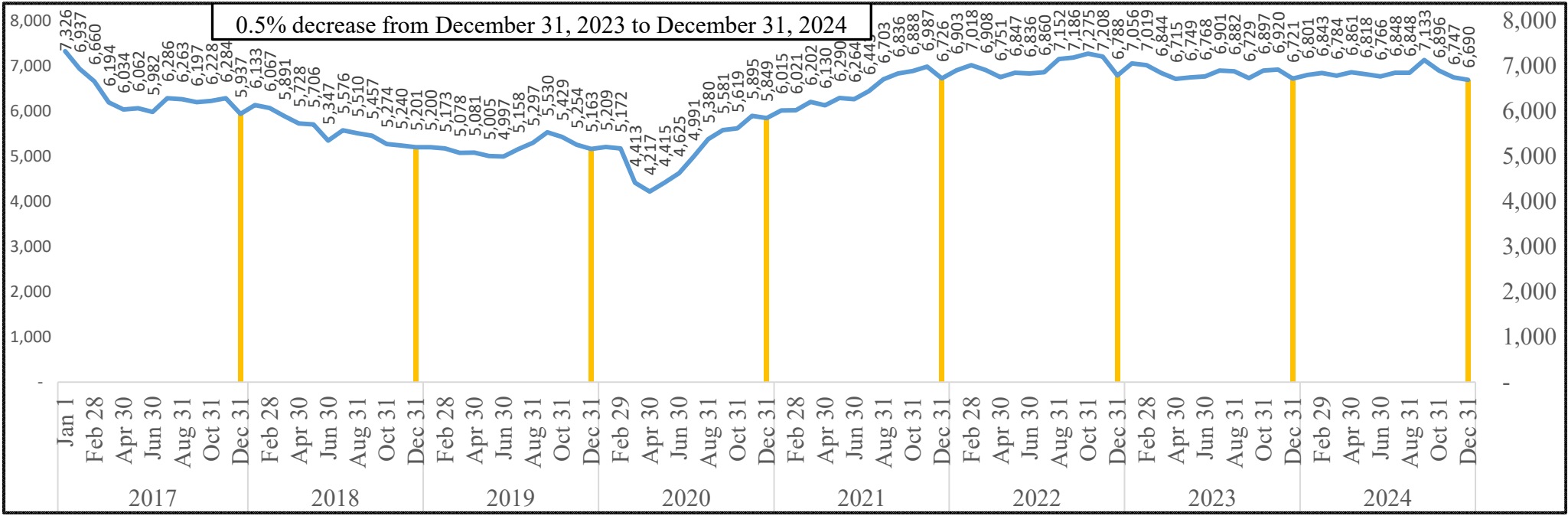

Chart C - Supplemental Graphs Nonsentenced Pretrial Jail Population



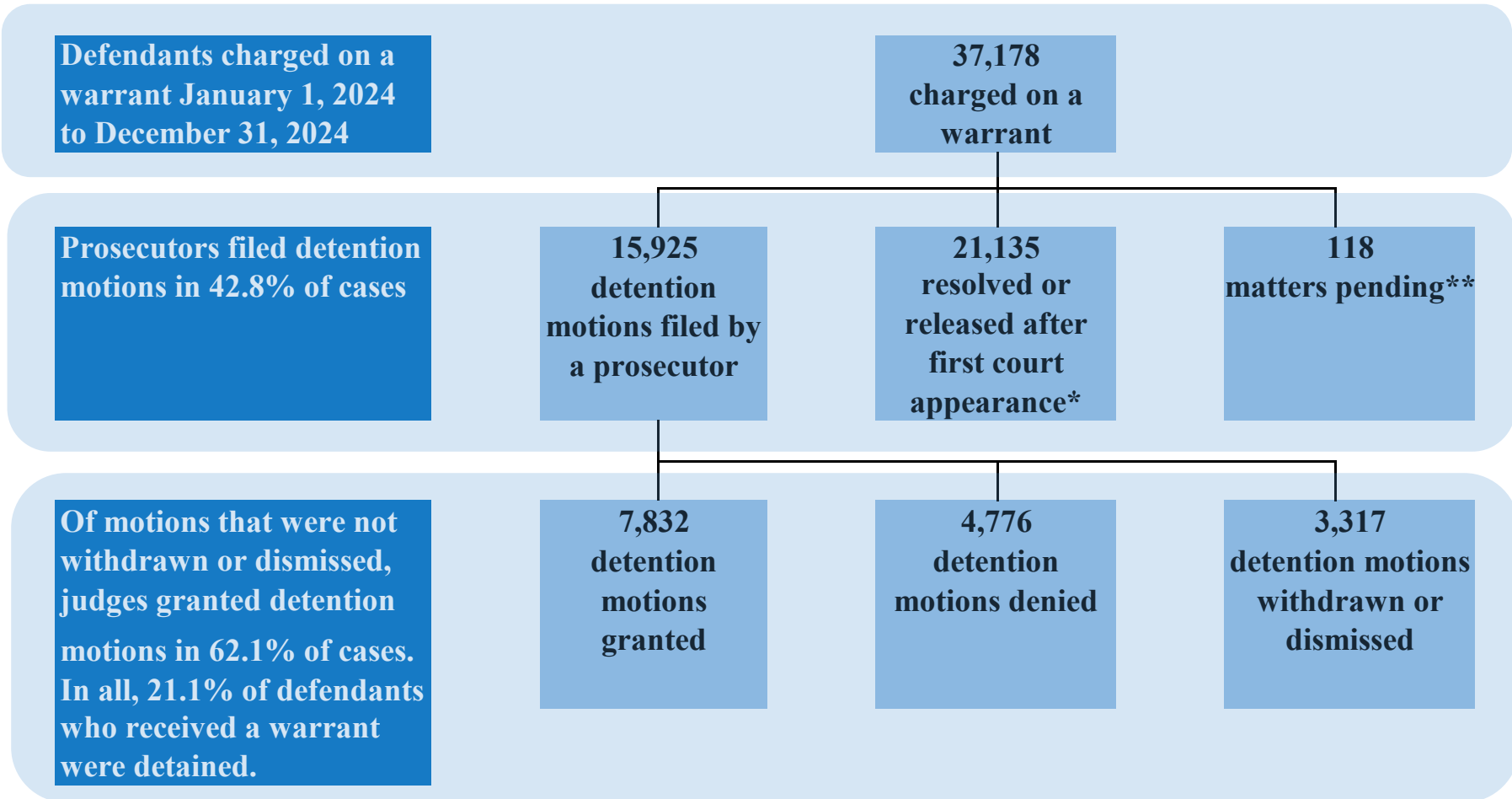
January 1, 2017 to December 31, 2024

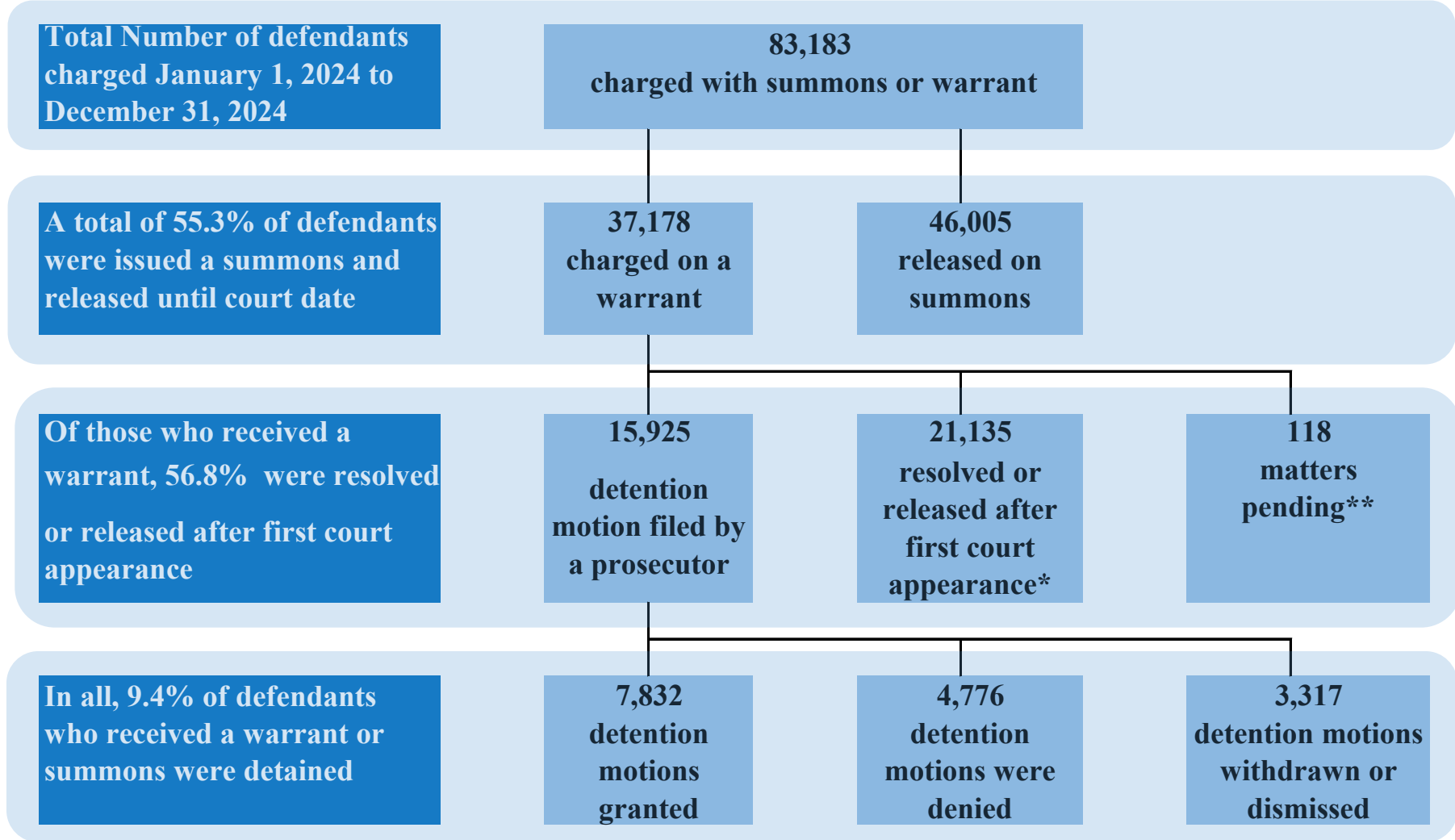
Chart D (Warrant) Pretrial Detention Decisions January 1, 2024 - December 31, 2024
