Topics

- Creation of an eCDR complaint via the new Custody Warrant complaint path this is in addition to the current "Summons" and "TBD" paths.
- Submittal to Superior Court for a judge's determination of Probable Cause and decision on a request to seal.
 - If Probable Cause is found and the judge authorizes a warrant, the complaint warrant is immediately docketed.
 - The case is sealed for 10 days if the judge grants the seal request. This can be extended for another 10 days if requested by the prosecutor prior to the expiration date.
- RST request to Superior Court when the Juvenile is taken into custody.



From the Portal, click the Juvenile Central Registry tile which is required to create a Juvenile complaint.
