This matter having come before the Court on the joint application of the plaintiffs and defendants to clarify and modify this Court's Order of April 16, 2013, and the plaintiffs and defendants having agreed on the form, substance and entry of the within Order; and the Court having considered the clarification proposed by the parties; and for good cause shown,

IT IS on this 23 day of April 2013,

**ORDERED** that the Court's Order dated April 16, 2013, regarding the stay of wave 7 cases subject to the defense motion for summary judgment because the plaintiffs' Crohn's disease is located outside the colon ("non-colonic Crohn's cases") ("defense motion") is supplemented and modified by the terms of this Order; and it is further

**ORDERED** that, pending resolution of the defense motion, the depositions to proceed in the wave 7 non-colonic Crohn's cases listed on attached Exhibit A shall be limited to depositions of plaintiffs, decision makers and physicians who have treated (both non-surgical and surgical

treatments, and clinical and non-clinical treatments) and/or diagnosed plaintiffs with regards to their IBD; and it is further

**ORDERED** that a copy of this Order shall be served on all counsel within seven (7) days of receipt by Defendants' counsel.
