IT IS on this 13 day of Oct, 2011, ORDERED that the



3. Notify this Court immediately of any matter affecting her standing before this Court; and
4. Have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by Cohn, Lifland, Pearlman, Herrmann & Knopf, LLP, who shall be responsible for the conduct of Elizabeth Middleton Burke; and it is
