**ORDERED** that Anita Modak-Truran shall make payment of fees as provided in the New Jersey Rules of Court, Rule 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order; and it is further

**ORDERED** that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further
