IT IS ON THIS 8th day of April, 2009

ORDERED that the Motion is granted and Kelley B. Stewart, Esq., is admitted to practice *Pro Hac Vice* before this Court pursuant to R. 1:21-2, for all purposes and in all proceedings in


connection with the above captioned case, in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that she shall:

1. abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against her and her firm that may arise out of her participation in this matter;
3. notify the Court immediately of any matter effecting her standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of Seeger Weiss LLP, who shall be responsible for the conduct of Kelley B. Stewart, Esq., and it is further

ORDERED that Kelley B. Stewart, Esq., shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28b-1(e), within thirty (30) days of the date of this order, and it is further

ORDERED that copies of this Order shall be served by attorneys for Plaintiff, Mark Spencer Monson, upon counsel for the defendants within seven (7) days of the receipt thereof.
