**ORDER ADMITTING CEDRIC EVANS,
ESQ. PRO HAC VICE**

AND NOW, Gibbons, Del Deo, Dolan, Griffinger & Vecchione, P.C., counsel for Defendants Hoffmann-La Roche Inc. and Roche Laboratories Inc. ("Roche") in the above-captioned action, upon notice to all interested parties, have moved before this Court for admission *Pro Hac Vice* of Cedric Evans, Esq.; the Court having considered the papers in support thereof; and the Court having found that Cedric Evans, Esq. is a member in good standing for the bar of the highest Court in the State where he resides and principally practices law and further good cause shown,

IT IS ON THIS 5 day of Dec, 2005

ORDERED that the Motion is granted and Cedric Evans, Esq. is admitted to practice *Pro Hac Vice* before this Court pursuant to R. 1:21-2, for all purposes and in all proceedings in connection with the actions comprising the Accutane® Litigation and any further such actions filed in this Court in the same manner as an attorney who is admitted to practice in this State and

is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that he shall:

1. abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter;
3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Gibbons, Del Deo, Dolan, Griffinger & Vecchione, P.C., who shall be responsible for the conduct of Cedric Evans, Esq.; and it is further

ORDERED that Cedric Evans, Esq. shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28B-1(e); and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that copies of this Order shall be served by attorneys for Roche upon Plaintiff within seven (7) days of the receipt thereof.
