
attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that he shall:

3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of Seeger Weiss LLP, who shall be responsible for the conduct of Andrew H. Bate, Esq., and it is further
