ORDERED that the Motion is granted and Sundeep Grewal is admitted to practice *pro hac vice* before this Court pursuant to Rule 1:21-2 for all purposes and in all proceedings in connection with the cases listed on Schedule A, provided that Sundeep Grewal shall:

1. Abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;
2. Consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions his and his firm that may arise


out of his participation in this matter;

ORDERED that Sundeep Grewal shall make payment of fees as provided in the New Jersey Rules of Court, Rule 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order, and it is further
