ORDERED that Hannah Whitney McMurry Schrock shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2, and 1:28b-1(e); and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that copies of this Order shall be served by attorneys for defendants, Barr Pharmaceuticals, LLC (f/k/a Barr Pharmaceuticals, Inc.), and Barr Laboratories, Inc., upon counsel for plaintiffs within seven (7) days of receipt hereof.
