

3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of PORZIO, BROMBERG & NEWMAN, P.C., who shall be responsible for the conduct of Jeffrey R. Schaefer, and it is further

ORDERED that Jeffrey R. Schaefer shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2, and 1:28b-1(e); and it is further
