**ORDERED** that Kimberly L. Beck shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2, and 1:28b-1(e); and it is further

**ORDERED** that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further
