ORDERED, that Lawrence Goldhirsch, Esq., shall have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in this State, who shall be held

responsible for them and for the conduct and cause of Lawrence Goldhirsch, Esq.; and it is further

ORDERED, that Lawrence Goldhirsch, shall be required to pay the New Jersey Lawyers' Fund for Client Protection, as required by all New Jersey attorneys pursuant to R. 1:28-1, and he agrees to make said contribution for subsequent years when they are due; and it is further
