
1. abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;

and
4. have all pleadings and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Gibbons P.C., who shall be responsible for the conduct of Richard L. Nahigian; and it is further
