ORDERED that **FREDERICK J. DAILEY, Esq.** shall make payment of fees as provided in the New Jersey Rules of Court, Rule 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order, and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that copies of this Order shall be served by attorneys for Plaintiff upon all counsel of record within seven (7) days of receipt thereof.
