THIS MATTER having been opened to the Court by Sedgwick LLP, attorneys for defendants, Ranbaxy Pharmaceuticals Inc., Ranbaxy Laboratories Inc., and Ranbaxy Inc., seeking an Order admitting G. Dawn Shawger McCord, Esq., attorney at law of the State of Texas, to the Bar of this Court *Pro Hac Vice*; and the local counsel for defendants (Sedgwick LLP) having represented that the defendants have no objection to the entry of the within Order;

IT IS on this *8th* day of *July*, 2011;
ORDERED as follows:

1. G. Dawn Shawger McCord, is hereby admitted *Pro Hac Vice* to appear in this matter for all purposes on behalf of defendants, Ranbaxy Pharmaceuticals Inc., Ranbaxy Laboratories Inc., and Ranbaxy Inc.
2. G. Dawn Shawger McCord is required to abide by the Rules governing this Court, including all disciplinary rules, R.1:20-1 and R. 1:28-2, and to notify the Court immediately of any matter affecting their standing at the bar of any other court.
3. G. Dawn Shawger McCord is deemed to consent to the appointment of the Clerk of the Court as agent upon whom service of process may be made for all actions against her or her firm that may arise out of their participation in this matter.

4. Reena Khanna, Esq., of the firm of Sedgwick LLP, and a member of the bar of this Court, has entered an appearance in this case and shall be counsel of record in accordance with R. 1:21-2(b)(4). All pleadings, briefs, and other papers filed with the Court shall be signed by Reena Khanna who shall be held responsible for them, the conduct of the cause, and G. Dawn Shawger McCord, Esq.

5. G. Dawn Shawger McCord, Esq. must, within ten (10) days, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit affidavits of compliance.


6. No delay in discovery, motions, trial, or any other proceeding shall occur or be requested by reason of the inability of G. Dawn Shawger McCord, Esq. to be in attendance.

7. Automatic termination of G. Dawn Shawger McCord, Esq.'s *Pro Hac Vice* admission will occur for failure to make the required annual payment to the Ethics Financial Committee and the New Jersey Lawyer's Fund for Client Protection. Proof of such payment, after filing proof of the initial payment shall be made no later than February each year.

8. Noncompliance with any of these requirements shall constitute grounds for removal.

9. Pursuant to Rule 1:21-2(b)(4) the admission of G. Dawn Shawger McCord, Esq. shall be subject to such further requirements concerning the participation of the New Jersey attorneys of record as the Court from time to time may deem necessary.

10. A copy of this Order shall be served on all parties within seven (7) days.
