
1. abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;

3. notify the Court immediately of any matter affecting her standing before this Court; and
4. have all pleadings and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Gibbons P.C., who shall be responsible for the conduct of Christiane R. Fife, Esq.; and it is further

ORDERED that Christiane R. Fife, Esq., shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order; and it is further
