**ORDERED**, that Steven Parilis, Esq. shall: abide by the rules governing the State of New Jersey, including all disciplinary rules; consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against the attorney or the attorney's firm that may arise out of the attorney's participation in the matter; notify the court immediately of any matter affecting the attorney's standing at the bar of any other court; and have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in this State, who shall be held responsible for them and for the conduct of the cause and of the admitted attorney therein; and it

is further

**ORDERED**, that Steven Parilis, shall be required to pay the New Jersey Lawyers' Fund for Client Protection, as required by all New Jersey attorneys pursuant to R. 1:28-1, and he agrees to make said contribution for subsequent years when they are due; and it is further

**ORDERED**, that Steven Parilis, Esq. shall make payment of fees as provided by the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2, and 1:28b-1(e), within thirty (30) days of the date of this order; and it is further

**ORDERED**, that the admission of Steven Parilis, Esq., shall not be cause for any adjournment in this matter; and it is further

**ORDERED**, the Clerk of the Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

**ORDERED**, that a copy of this Order shall be served upon all counsel within \_\_ days of its receipt by the movant.
