THIS MATTER has been presented to the Court upon the application of The Lanier Law Firm, attorneys for Plaintiff in the above-captioned matter, upon notice to all interested parties, having moved before this Court for admission *Pro Hac Vice* of Spencer P. Browne, Esq. is a member in good standing of the bar of the highest Court in the State where he is domiciled and principally practices law; and further good cause shown, it is hereby;

ORDERED THIS 30 day of Aug, 2011;

1. Spencer P. Browne, Esq. shall be and is admitted to practice *Pro Hac Vice* before this Court pursuant to *R. 1:21-2*, for all purposes and in all proceedings in which he or his firm, The Lanier Law Firm, have filed and served action, in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey;

3. Spencer P. Browne shall consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter;
4. Spencer P. Browne shall notify the Court immediately of any matter effecting his standing before this Court;
5. Spencer P. Browne shall have all pleadings, briefs and other papers filed with the Court signed by an attorney-at-law of this Court employed by The Lanier Law Firm, authorized to practice in this State, who shall be responsible for the conduct of Spencer P. Browne, and it is;
