
admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that each shall:

1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process maybe made for all actions against her or her firm that may arise out of her participation in this matter;
3. notify the Court immediately of any matter affecting her standing at the bar of any Court; and
4. have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Nagel, Rice & Mazie, LLP, who shall be responsible for them, for the conduct of the cause of Roberta A. Ashkin, Esq., it is further

ORDERED that Roberta A. Ashkin, Esq., shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2 and 1:28B-1(e) within 30 days of the date of this Order and it is further

ORDERED that a copy of this Order shall be served by attorneys for plaintiffs upon defendants within seven (7) days of their receipt thereof.
