THIS MATTER being opened to the Court by David L. Toups, an attorney admitted to the practice of law in the State of Texas, and the Court having considered the papers in support thereof; and the Court having found that Mitchell A. Toups is a member in good standing of the bar of the highest Court in the State where he is domiciled and principally practices law and further good cause being shown,

ORDERED that the Motion is granted and Mitchell A. 2. Consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter;
3. Notify this Court immediately of any matter affecting his standing before this Court; and
4. Have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by Balkin & Eisbrouch, LLC, who shall be responsible for the conduct of Mitchell A. Toups; and it is

FURTHER ORDERED that Mitchell A. Toups shall make payment of fees as provided in the New Jersey Rules of Court, R.1:28-1(b), 1:28-2 and 1:28b-1(e) within thirty (30) days of the date of this Order; and it is

FURTHER ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is

FURTHER ORDERED that copies of this Order shall be served by attorneys for plaintiffs upon counsel for the defendants within seven (7) days of the receipt thereof.
