ORDERED as follows:

Counsel receiving this Order through computerized electronic medium (E-Mail) shall be deemed by the court to have received a copy of the filed original court document. Any document served pursuant to this Order shall be deemed to be served by mail pursuant to R.1:5-2.

1. The time by which defendant, Sinclair Industrial Supply Co., is permitted to file an answer to the complaint is hereby extended to **December 22, 2017**.
2. Defendant Sinclair Industrial Supply Co. may file a summary judgment motion no later than **January 19, 2018** with a final return date of **February 16, 2018**.
3. As to plaintiff and defendants' Miller & Chitty and Cleaver Brooks, there will be a stay of discovery until **December 27, 2017**.
4. Defendants Miller & Chitty and Cleaver Brooks shall produce corporate designees within sixty (60) days upon being served with Notice to Produce and Document Demands. These depositions must be completed by **February 28, 2018**.
5. Plaintiff and defendants Miller & Chitty and Cleaver Brooks may engage in additional fact witness discovery, which must be completed by **February 28, 2018**. No additional summary judgment motions resulting from this fact witness discovery may be filed without leave of court.

6. Plaintiff's expert liability report, if any, must be served by **March 28, 2018**.
7. Defendants Miller & Chitty and Cleaver Brooks expert liability reports and expert economic loss report, if any, must be served by **April 30, 2018**.
8. Expert depositions, if any, must be completed by **May 11, 2018**.
9. Pretrial Information Exchange submissions shall be due upon a date agreed to by parties with consent of the court.
10. Trial-Ready date is scheduled for **June 4, 2018**. *(The December 4, 2017 trial is adjourned.)*
