Counsel receiving this Order through computerized electronic medium (E-Mail) shall be deemed by the court to have received a copy of the filed original court document. Any document served pursuant to this Order shall be deemed to be served by mail pursuant to R.1:5-2.

Defense counsel shall notify plaintiffs' counsel within thirty (30) days of the date of this Order if their client was incorrectly named in the Complaint. Counsel may be barred from raising this defense at a later time for failure to comply.

These matters are hereby consolidated for discovery, case management and trial.

PLEADINGS

- _____ 2013 The time by which plaintiff may serve summons and complaint upon defendant(s) _____ is extended to this date.
- _____ 2013 The time by which defendant _____ may file an answer to the complaint is extended to this date.
- _____ 2013 The complaint is hereby amended to reflect wrongful death claim on behalf of plaintiff _____ and to name _____ as executor(trix) of the estate. Any defendants having previously filed an answer to the complaint are hereby deemed to have filed an amended answer to the complaint without any further filing.

DISCOVERY

- _____ 2013 Plaintiff shall serve answers to standard interrogatories, provide the information required by paragraph VII.B.1.a. of the General Order, and shall advise defendants whether the plaintiff is available for deposition and, if not, the reasons therefore by this date.
- _____ 2013 Plaintiff shall serve answers to wrongful death interrogatories (and serve wrongful death reports) by this date.
- _____ 2013 If answers to standard interrogatories were served prior to the initial case management conference and did not include identification of fact witnesses, supplemental / amended answers to interrogatories identifying fact witnesses shall be served by this date.
- _____ 2013 Plaintiff shall provide answers to standard interrogatories and all prior discovery to all new defendants by this date.
- _____ 2013 A limited deposition of the plaintiff shall be conducted by this date. It shall be limited to a direct exam as to product identification by counsel representing defendants impleaded into this matter after the plaintiff's deposition was originally taken. In the event additional product identification testimony is elicited, other counsel may cross-examine plaintiff. In addition, any counsel may inquire as to plaintiff's health status.
- _____ 2013 Defendants shall serve answers to standard interrogatories by this date.
- _____ 2013 Plaintiff shall propound supplemental interrogatories and document requests by this date.
- 4/30 2013 Defendants shall serve answers to supplemental interrogatories and document requests by this date.
- _____ 2013 Defendants shall propound supplemental interrogatories and document requests by this date.
- 3/29 2013 Plaintiff shall serve answers to supplemental interrogatories and document requests by this date.
- _____ 2013 Plaintiff depositions shall be concluded by this date. Plaintiff's counsel shall contact the Special Master within one week of this deadline if plaintiff depositions are not completed by this date.
- 5/31 2013 Fact discovery, including depositions, shall be completed by this date. Plaintiff's counsel shall contact the Special Master within one week of this deadline if all fact discovery is not completed.
- 6/28 2013 Depositions of corporate representatives shall be completed by this date.

_____ 2013 Any and all documents responsive to Notices to Produce shall be produced at least one week prior to a corporate representative's deposition, if not produced in accordance with deadlines set forth for responses to document requests.
