DISCOVERY

- August 7, 2015 Plaintiff Forese to file motion seeking leave to amend complaint to add plaintiffs' daughters as parties.
- August 12, 2015 Defendant McPherson's deposition shall be completed by this date.

August 21, 2015 Executed medical authorizations for minor plaintiffs impleaded in amended complaint must be served by this date.

October 12, 2015 Plaintiff's liability and economist expert reports must be served by this date. Failure to serve economical report by this date shall be deemed a waiver by plaintiff to serve same.

November 9, 2015 Defense medical expert reports to be served by this date or ninety (90) days from date defense medical examinations are completed, whichever date is later.

January 12, 2016 Defense liability and economist expert reports, if any, to be served by this date or within ninety (90) days from service of plaintiff's expert reports, whichever date is later.

May 16, 2016 Trial.

Defendants may file dispositive motions.

Plaintiffs' counsel to advise whether plaintiffs are amenable to the mediation process.
