: **CONSENT ORDER**
: **EXTENDING DEADLINE OF AUGUST 7,**
: **2014 ORDER**

THIS MATTER having been assigned to the Honorable Brian R. Martinotti,
J.S.C. pursuant to the Supreme Court’s Order of April 12, 2011 ordering centralized case
management of DePuy ASR™ Hip Implants, (hereinafter referred to as “DePuy”),

Whereas, on August 7, 2014, the Court entered an Order of dismissal for the
claims of the plaintiffs in the process of being resolved pursuant to the Settlement
Agreement;

Whereas, the parties consented and stipulated to the dismissal of these plaintiffs’
cases at that time without prejudice;

Whereas, on October 6, 2014, 60 days from the date of entry of the Order, the
dismissals of the cases identified in the Order were to convert to dismissals with
prejudice;

Whereas, on October 1, 2014, the Court entered an Order extending the deadline
on which cases would convert to dismissal with prejudice;

Whereas, Section 13.3 of the Settlement Agreement holds that:

The Claims Processor shall retain control of the Release and
Dismissal With Prejudice Stipulation of any particular U.S. Program

Claimant until such time as (a) DePuy's Walk Away Right shall have expired without DePuy exercising any such Walk Away Right, and (b) such Claimant's PART A Base Award has been funded to the appropriate Escrow Account pursuant to the Escrow Agreement, at which time such Dismissal With Prejudice Stipulation and such Enrolled Program Claimant's Release shall be delivered to DePuy (and, without limitation, DePuy shall be free to file or cause to be filed such Dismissal With Prejudice Stipulation and/or Release in any relevant action or proceeding). And for good cause shown, the following Order is hereby entered:

IT IS on this ____ day of September 2014,

ORDERED that the November 15, 2014 date upon which dismissals of cases identified in Appendix A, attached hereto, is hereby extended to January 15, 2015, at which time all cases identified in Appendix A will convert to dismissals with prejudice.
