OBLIGATIONS OF UNREVISED PLAINTIFFS


This matter having come before the Court at the Case Management Conference on December 1, 2016, in the presence of Co-Lead Counsel for the DePuy ASR New Jersey Plaintiffs, Daniel R. Lapinski, Co-Lead Counsel for the DePuy ASR MDL Plaintiffs, Ellen Relkin, and Lead Counsel for the Defendants, Susan M. Sharko of Drinker Biddle, and for good cause shown,

And whereas, pursuant to Amended Case Management Order No. 31, unrevised plaintiffs who elected to continue with their case were obligated to complete initial discovery within 90 days of their election deadline, including: (1) submission of a complete, updated and executed Plaintiff Fact Sheet accompanied by all required document production; (2) current medical authorizations; and (3) damage interrogatories attached to Case Management Order No. 31 as Exhibit B;

And whereas, attached Appendix A is a listing of unrevised plaintiffs who have not complied with one or more of their discovery obligations under Amended Case Management Order No. 31;

IT IS on this 3rd January 2017 day of ~~December 2016~~ ORDERED as follows:

1. All plaintiffs identified on Appendix A must comply with Amended Case Management Order No. 31 within 60 days of the entry of this order, ~~by January 2017~~.
2. In the event that plaintiffs identified on Appendix A fail to comply with Case Management Order No. 31 by the above date, counsel for defendants shall be permitted to file motions to dismiss for failure to comply with Case Management Orders.
