
All prior orders remain in full force and effect except as modified by this Order

**THIS MATTER** having been opened to the Court on its own motion; Though all captions are mentioned above, this is merely a convenience for Counsel and the Court, This matter has not been designated for MCL status, nor has it been formally consolidated; There is a pending MDL matter in which discovery has been exchanged and proceeding; Trial dates have been set in the MDL beginning in September 2014; There is a remand motion pending in the MDL regarding cases which were removed to Federal Court (approximately 35 New Jersey Cases); The Court hereby enters the following order:

**IT IS** on this 23rd day of June 2015;

**ORDERED** as follows:

1. The Discovery End Date for the above captioned matters is now **December 31, 2015**.
2. Counsel shall meet and confer and set a discovery schedule for the following three cases:
  - a. *Chrisman v. DePuy Orthopaedics, Inc., et al.* (Docket No. BER-L-1813-14).
  - b. *Nagy v. DePuy Orthopaedics, Inc., et al.* (Docket No. BER-L-7660-13).
  - c. *Bifano v. DePuy Orthopaedics, Inc., et al.* (Docket No. BER-L-6832-13).
3. The trial order will be as follows: *Chrisman v. DePuy*, *Bifano v. DePuy*, and *Nagy v. DePuy*.
4. Plaintiff Liaison counsel shall reach out to the Steering Committee in the MDL to address access to documents covered by the Protective Order.
5. The pending notice of deposition in the *Bates* matter need not be addressed.
6. The next case management conference is scheduled for September 15, 2015 at 10:15am.
