All prior orders remain in full force and effect except as modified by this Order


**THIS MATTER** having been opened to the Court on its own motion; Though all captions are mentioned above, this is merely a convenience for Counsel and the Court, This matter has not been designated for MCL status, nor has it been formally consolidated; There is a pending MDL matter in which discovery has been exchanged and proceeding; Trial dates have been set in the MDL beginning November 3, 2014; There is a remand motion pending in the MDL regarding cases which were removed to Federal Court (approximately 35 New Jersey Cases); The Court hereby enters the following order:

IT IS on this 8 day of October 2014;

**ORDERED** as follows:

1. Ellen Relkin is hereby appointed as liason counsel and shall meet and confer regarding a New Jersey specific Protective Order so discovery can be exchanged from Defendants with the New Jersey Pinnacle Plaintiffs.
2. The following cases were subject to ASR case management and now are subject to the present discovery requirements in this litigation:

3. The following plaintiffs have not complied with the order dated June 10, 2014. The complaints are dismissed without prejudice and will be reinstated upon compliance with this order:

  - b. Kevin Mollaun (Docket No. BER-L-6849-12)
  - c. Debbie Stafford as Personal Representative of the Estate of Thomas Root  
(Docket No. BER-L-7301-12)
  - d. Frank Bifano (Docket No. BER-L-6832-12)

4. Plaintiff Judy Bowers (Docket No. BER-L-6834-12) is dismissed without prejudice for failure to provide a signed authorization as ordered on June 10, 2014. The complaint will be reinstated upon compliance with this order.
5. Counsel shall meet and confer within the next 21 days to discuss an order for case-specific discovery and shall present same to the court at the next case management conference.
6. Any counsel that received a deficiency letter shall respond to counsel's deficiency letter within 30 days.
7. The Discovery End Date for the above captioned matters is **December 14, 2014**.
8. The Next Case Management Conference for the above captioned matters will be November 19, 2014 at 10:00am.
