Plaintiff Kathy Ryan;


WHEREAS, Plaintiff continues to pursue a cause of action related to Kathy Ryan's RIGHT and LEFT HIP;

IT IS on this 6 day of October 2015,


**ORDERED** that the claims of Plaintiff Kathy Ryan shall be reinstated to an active docket status as to the claims related to her ASR hips.


