

This matter being opened to the court by Jonathan B. Acklen, a New Jersey attorney and attorney of record for Plaintiffs, to permit Kelly Clifford Rambo, an attorney admitted to the practice of law in the Commonwealth of Pennsylvania, to participate with other counsel for Plaintiffs in all phases of trial, and it appearing that Kelly Clifford Rambo is a licensed attorney in good standing in the Commonwealth of Pennsylvania and it appearing that there has been an attorney/client relationship with the Plaintiffs for an extended period of time:

IT IS on this 25 day of January, 2013 hereby

**ORDERED** that Kelly Clifford Rambo, Esquire be and hereby is admitted *Pro Hac Vice* and is authorized to appear and participate with other counsel for Plaintiffs in all phases of the trial, subject to the following conditions:

1. Kelly Clifford Rambo shall abide by the Rules of Court for the State of New Jersey, including all disciplinary rules, *R. 1:20-1* and *R. 1:28-2*;
2. Kelly Clifford Rambo shall, and hereby does consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against Plaintiffs that may arise out of his participation in this matter;
3. Kelly Clifford Rambo shall notify the Court immediately of any matter effecting her standing at the Bar of any other jurisdiction;
4. Kelly Clifford Rambo shall have all pleadings, briefs and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Cohen & Feeley, P.C., who shall be responsible for the conduct of Kelly Clifford Rambo;
5. Kelly Clifford Rambo cannot be designated as trial counsel;
6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Kelly Clifford Rambo to be in attendance;
7. Kelly Clifford Rambo must, within ten (10) days, pay the fees required by *R. 1:20-1(b)* and *R. 1:28-2* and submit an affidavit of compliance;
8. *Pro Hac Vice* admission will automatically terminate for failure to make the initial and annual payment required by *R. 1:20-1(b)* and *R. 1:28-2*;
9. Non-compliance with any of the terms of this order shall constitute grounds for removal;
10. A copy of this Order shall be served on all parties within seven (7) days hereof.
