IT IS on this 15th day of October, 2019, ORDERED as follows:

1. STIPULATIONS OF DISMISSAL

Stipulations of dismissal with or without prejudice shall be submitted to the court with an incorporated dismissal Order to be signed by the Court.

2. CASE LISTS

Weitz & Luxenberg shall submit a corrected case list to the court by October 16, 2019.

3. DECEASED PLAINTIFFS

The cases listed in Exhibit A have been identified by counsel for Merck as including a deceased plaintiff for which there has been no substitution of an authorized Personal Representative. Plaintiffs' Counsel shall promptly review the attached Exhibit A for accuracy and will notify counsel for Merck within 14 days of this Order whether any corrections need to be made. At the conclusion of those 14 days, if necessary, a revised Exhibit A will be substituted and will be the controlling Exhibit A going forward. With respect to those plaintiffs identified on Exhibit A, within 90 days of the Third Circuit's decision in Merck Sharp & Dohme Corp. v. Doris Albrecht,

("Albrecht Opinion") plaintiffs' counsel shall either dismiss the plaintiff's claims with prejudice or move, pursuant to R. 4:34-1, to substitute an authorized Personal Representative for the Estate of the deceased plaintiff. However, upon good cause being shown, and only if the request is made within 60 days following the Albrecht Opinion, Plaintiff's counsel can seek an extension of the 90 day period to obtain substitution pursuant to R. 4:34-1.

If a motion pursuant to R. 4:34-1 is not filed within the 90 day period for a plaintiff listed on Exhibit A (or within the extended period, if an extension is granted), the claims of that plaintiff will be dismissed with prejudice pursuant to an Order submitted to the court under the five day rule.

4. CASES PREVIOUSLY WITHDRAWN FROM CORE DISCOVERY

The cases listed in Exhibit B have been identified by counsel for Merck as including a plaintiff named for core discovery that was withdrawn from discovery at the request of plaintiff's counsel based on the representation by plaintiff's counsel that the case would be dismissed, but for which a signed stipulation of dismissal was not received. Plaintiffs' Counsel shall promptly review the attached Exhibit B for accuracy and will notify counsel for Merck within 14 days of this Order whether any corrections need to be made. At the conclusion of those 14 days, if necessary, a revised Exhibit B will be substituted and will be the controlling Exhibit B going forward. With respect to those plaintiffs identified on Exhibit B, plaintiffs shall appear for a deposition with 45 days of the date of this Order. If the plaintiffs do not appear for deposition within this deadline, Merck shall file a dismissal order with prejudice under the five-day rule.

5. DATES FOR PLAINTIFF DEPOSITIONS


Within 14 days of the request from defense counsel, plaintiffs' counsel in all core discovery cases shall provide dates for the plaintiff's deposition to proceed within the next 60 days or advise that they have been unable to locate their client. If plaintiff's counsel fails to provide dates or advise that they have been unable to locate their client, defense counsel may issue a unilateral deposition notice for the plaintiff. In response to the unilateral deposition notice, plaintiff shall appear on the date noticed or, within five days of receipt of the unilateral deposition notice, plaintiff's counsel shall provide other dates when plaintiff is available to be deposed within that original 60 day time-period.

Counsel will work to address an alternative procedure for those cases in which plaintiff's counsel cannot locate their client selected for core discovery and will submit a separate order addressing this issue. If counsel are unable to agree upon a procedure, the issue will be discussed at the next Case Management Conference.

6. CASE MANAGEMENT ORDERS

All Case Management Orders shall be submitted to the court within 10 days of the Case Management Conference. If the parties do not consent to the proposed Case Management Order, they must still comply with this deadline and shall submit their separate orders to the court under the five day rule.

7. The next Case Management Conference is scheduled on January 15, 2020, at 11:00 a.m. EST in Courtroom 403.
