CASE MANAGEMENT ORDER

THIS MATTER having come before the Court for phone conferences on October 19, 21, and 22, 2010 and for good cause shown,

IT IS on this 18th day of November, 2010, **ORDERED** as follows:

1. The deadlines set forth in this Order supersede the deadlines set forth in the Order dated August 27, 2010.
2. The following schedule shall apply to *Alison Rosenberg v. Merck Sharp & Dohme Corp.*, Docket No. ATL-L-3644-08 (MT) ("Rosenberg"):
 - a) Oppositions to Kemp and Summary Judgment Motions are due on or before November 1, 2010.
 - b) Reply Briefs to Kemp and Summary Judgment Motions are due on or before November 8, 2010.
 - c) Motions in Limine are due on or before November 9, 2010.
 - d) Oppositions to Motions in Limine are due on or before November 16, 2010.
 - e) Reply Briefs in support of Motions in Limine are due on or before November 23, 2010.
 - f) The court will set a hearing schedule for these motions in December 2010.

3. The following schedule shall apply to *Harriett Singer v. Merck Sharp & Dohme Corp.*, Docket No. ATL-L-4073-08 (MT) ("Singer"):


- a) Oppositions to Kemp and Summary Judgment Motions are due on or before November 3, 2010.
- b) Reply Briefs to Kemp and Summary Judgment Motions are due on or before November 10, 2010.
- c) Motions in Limine are due on or before November 9, 2010.
- d) Oppositions to Motions in Limine are due on or before November 16, 2010.
- e) Reply Briefs in support of Motions in Limine are due on or before November 23, 2010.
- f) The court will set a hearing schedule for these motions in December 2010.

4. The following schedule shall apply to *Ann Conway v. Merck Sharp & Dohme Corp.*, Docket No. ATL-L-4075-08 (MT) ("Conway"):

- a) Expert Discovery shall be completed on or before November 23, 2010.
 - The deposition of Dr. Joseph Marged, D.D.S. shall be conducted on November 17, 2010.
 - The deposition of Dr. Raymond Fonseca, D.M.D shall be conducted on November 18, 2010.
 - The deposition of Dr. Barry Gruber, M.D. shall be conducted on November 19, 2010.
 - The deposition of Dr. Raymond Precheur, D.M.D shall be conducted on November 23, 2010.
- b) Kemp and Summary Judgment Motions are due on or before December 3, 2010.
- c) Oppositions to Kemp and Summary Judgment Motions are due on or before December 13, 2010.
- d) Reply Briefs to Kemp and Summary Judgment Motions are due on or before December 20, 2010.
- e) Motions in Limine are due on or before December 14, 2010.
- f) Oppositions to Motions in Limine are due on or before December 29, 2010.

g) Reply Briefs to Motions in Limine are due on or before January 5, 2010.
