IN RE: FOSAMAX® LITIGATION

THIS MATTER, having come before the Court at a case management conference on July 16, 2024, and counsel for Plaintiffs and counsel for Defendants having been present, and for good cause having been shown;

IT IS on this 30th day of July, 2024, **ORDERED** as follows:

1. DECEASED PLAINTIFFS

a. The cases listed in Exhibit A have been identified as including a deceased Plaintiff for which there has been no substitution of an authorized Personal Representative. For those cases identified in Exhibit A, if Plaintiffs do not move either to dismiss the Plaintiff's claims or move pursuant to R. 4:34-1, to substitute an authorized Personal Representative for the Estate of the deceased Plaintiff by September 3, 2024, the claims of that Plaintiff will be dismissed without prejudice. This deadline may be extended by the Court if plaintiffs' counsel files a motion to extend and demonstrates good cause.

b. From the date a case is dismissed without prejudice, Plaintiff will have 60 days to file a motion to reinstate their case and substitute an authorized Personal Representative for the Estate of the deceased Plaintiff or the claims of that Plaintiff may, upon motion, be dismissed with prejudice.

c. Plaintiffs filing motions pursuant to R. 4:34-1 must continue to include in the attorney certification filed therewith the language set out in the CMO dated December 13, 2022 from the November 17, 2022 Case Management Conference, or the motion will be denied.

2. STATUS OF PLAINTIFFS

Plaintiffs' counsel shall continue to identify for the court and Defense counsel those Plaintiffs who are deceased and do not already appear on Exhibit A to this Case Management Order. Plaintiffs' counsel shall continue in their efforts to determine the status of their clients and update defense counsel and the court accordingly.

3. NEXT CASE MANAGEMENT CONFERENCE

The next Liaison counsel meeting and Case Management Conference is combined and scheduled on August 29, 2024, at 10:00 a.m. EST via Zoom link provided by the Court, unless otherwise notified by the Court. Liaison counsel are required to attend and attendance by all other counsel is optional. An agenda for the Case Management Conference shall be submitted to the Court seven days before the liaison counsel meeting.
