THIS MATTER, having come before the Court at a case management conference on January 24, 2023, and counsel for Plaintiffs and counsel for Defendants having been present, and for good cause having been shown;

IT IS on this 3rd day of February, 2023, **ORDERED** as follows:

1. DECEASED PLAINTIFFS

The cases listed in Exhibits A, B, and C were previously identified as including a deceased Plaintiff for whom there has been no substitution of an authorized Personal Representative. For those cases identified in Exhibits A, B, and C, if the deadline for Plaintiffs to file a motion pursuant to R. 4:34-1, dismissal, or amended complaint has passed and a motion to dismiss, voluntary dismissal, or amended complaint has not been filed, defense counsel may file a motion to dismiss these cases without prejudice. This deadline may be extended by the Court if plaintiff's counsel files a motion to extend and demonstrates good cause. Plaintiffs filing motions pursuant to R. 4:34-1 must continue to include in the attorney certification filed therewith the language set out in the CMO dated December 13, 2022 from the November 17, 2022 Case Management Conference ("November 2022 CMO"), or the motion will be denied.

2. **STATUS OF PLAINTIFFS**

Plaintiffs' counsel shall continue to identify for the Court and Defense counsel those Plaintiffs who are deceased and do not already appear on prior Case Management Order Exhibits.

Plaintiffs' counsel shall continue in their efforts to determine the status of their clients and update defense counsel and the Court accordingly.

3. CASES WITH DELINQUENT PROOF OF USE AND/OR PROOF OF INJURY AND/OR PROOF OF PRODUCT IDENTIFICATION

Plaintiffs' liaison counsel were provided notice that the Plaintiffs listed in Exhibit D did not provide any evidence of proof of use as required by the CMO dated August 10, 2022 from the July 25, 2022 Case Management Conference ("July 2022 CMO") and by the November 2022 CMO. Plaintiffs' liaison counsel were also provided notice that the Plaintiffs listed in Exhibit E did not provide any records regarding generic product identification as required by the July 2022 CMO and November 2022 CMO.

Prior to filing motions to dismiss the cases listed on Exhibits D and E on the basis of a lack of proof of use or generic product identification, defense counsel must provide email notice to Plaintiffs' counsel advising that proof of use and generic product identification, respectively, has not been received and if it is not provided within 14 days of the email notice, a motion to dismiss without prejudice will be filed. Defendants are granted permission to file motions to dismiss these Exhibit D and E cases without prejudice if no evidence of proof of use or generic product identification is provided within 14 days of the email notice.

4. NEXT CASE MANAGEMENT CONFERENCE

The next Case Management Conference is scheduled for April 4, 2023, at 1:30 p.m. EST via zoom link provided by the court, unless otherwise notified by the court. A liaison counsel meeting is scheduled for March 28, 2023 at 1:30 p.m. EST via a zoom link provided by the court, unless otherwise notified by the court. An agenda for the Case Management Conference shall be submitted to the court 7 days before the liaison counsel meeting.
