**ORDER ADMITTING

This matter being opened to the Court by Patrice S. O'Brien, Esq., a New Jersey attorney and the attorney of records for Apotex Inc. and Apotex Corp., to permit Charles Fitzpatrick, III, Esq., attorney admitted to the practice of law in the State of Pennsylvania, to participate with other counsel for Defendants in all phases of trial, and it appearing that Charles Fitzpatrick, III, Esq. is a licensed attorney in good standing in the State of Pennsylvania, and it appearing that Charles Fitzpatrick, III, Esq. is not an attorney admitted to the practice of law in the State of New Jersey.

It is on this 15 day of May, 2013, ORDERED that Charles Fitzpatrick, III, Esq. be and hereby is admitted *pro hac vice* and is authorized to appear and participate with other counsel for Defendants in all phases of trial in the cases listed on the attached "Schedule A", subject to the following conditions:

1. Charles Fitzpatrick, III, Esq. shall abide by the *New Jersey Court Rules*, including all

disciplinary rules, *R. 1:20-1* and *R. 1:28-2*.

2. Charles Fitzpatrick, III, Esq. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon whom service of process may be made for all actions against Charles Fitzpatrick, III, Esq. that may arise out of their participation in this matter.

3. Charles Fitzpatrick, III, Esq. shall immediately notify the court of any matter affecting their standing at the Bar of any other jurisdiction.

4. Charles Fitzpatrick, III, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. Charles Fitzpatrick, III, Esq. cannot be designated as trial counsel.



7. Charles Fitzpatrick, III, Esq. must within ten (10) days, pay the fees required by *R. 1:20-1 (b)* and *R. 1:28-2* and submit an affidavit of compliance.

8. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by *R. 1:20-1 (b)* and *R. 1:28-2*.

9. Non-compliance with any of the terms of this order shall constitute grounds for removal.

10. A copy of this Order shall be served on all parties within seven (7) days of the date hereof.
