**ORDER**

**WHEREAS**, Defendant Apotex Corp., by and through its attorneys Rawle and Henderson, LLP, upon notice to all interested parties, has moved before this Court for admission *pro hac vice* of Charles Fitzpatrick, III, Esquire; and the Court having considered the papers submitted in support thereof; and the Court having found that Charles Fitzpatrick, III, Esquire, is a member in good standing before the bar of the highest Court of the State where he is domiciled and principally practices law; and for other good cause shown.

**IT IS** on this 1 day of Dec, 2011, hereby **ORDERED** that the motion is granted, and Charles Fitzpatrick, III, Esquire, is admitted to practice *pro hac vice* before this Court, pursuant to R. 1:21-2, for all purposes and in all proceedings in the same manner as an attorney who is admitted to practice in the State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that each shall:


1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary Rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him or his firm that may arise out of his participation in these cases;
3. notify the Court immediately of any matter affecting him standing at the bar of any Court; and
4. have all pleadings, briefs, and other papers filed in this Court signed by and attorney-at-law of this Court employed by the law firm of Rawle and Henderson, LLP, who shall be responsible for them, for the conduct of the cause of Charles Fitzpatrick, III, Esquire.

**IT IS FURTHER ORDERED** that Charles Fitzpatrick, III, Esquire, shall make payment of all fees due to the State of New Jersey within 30 days of the entry of the *pro hac vice* Order allowing for admission and as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2, and 1:28B-1(e); and

**IT IS FURTHER ORDERED** that the Clerk of the Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and

**IT IS FURTHER ORDERED** that a copy of this Order shall be served by the attorneys for Defendant upon Plaintiff within seven (7) days of their receipt thereof.
