**WHEREAS**, Defendant Merck Sharp & Dohme Corp., by and through its attorneys Cooper Levenson April Niedelman & Wagenheim, P.A., upon notice to all interested parties, has moved before this Court for admission *pro hac vice* of Craig Thompson, Esquire; and the Court having considered the papers submitted in support thereof; and the Court having found that Craig Thompson, Esquire, is a member of good standing before the Bar of the highest Court of the State where he is domiciled and principally practices law; and for other good cause shown;

IT IS on this 31 day of Aug, 2010, **ORDERED** that the motion is granted, and Craig Thompson, Esquire, is admitted to practice *pro hac vice* before this Court with regard to the cases set forth in the attached Schedule A, pursuant to R. 1:21-2, for all purposes and in all proceedings in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that each shall:

1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary rules;

2. consent to the appointment of the Clerk of the Supreme Court as an agent upon who service of process may be made for all actions against him or his firm that may arise out of his participation in these cases;


3. notify the Court immediately of any matter affecting his standing at the bar of any Court; and

4. have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Cooper Levenson April Niedelman & Wagenheim, P.A., who shall be responsible for them and for the conduct of the cause of Craig Thompson, Esquire.

**IT IS FURTHER ORDERED** that Craig Thompson, Esquire, shall make payment of all fees due to the State of New Jersey within 30 days of the entry of the *pro hac vice* Order allowing for admission and as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2 and 1:28B-1(e).

**IT IS FURTHER ORDERED** that the Clerk of the Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection.

**IT IS FURTHER ORDERED** that a copy of this Order shall be served by attorneys for Defendant upon Plaintiffs via LexisNexis File & Serve within seven (7) days of their receipt thereof.
