

1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary Rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against her or her firm that may arise out of his participation in these cases;
3. notify the Court immediately of any matter affecting her standing at the bar of any Court;
4. have all pleadings, briefs, and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of THE LEVENSTEN LAW FIRM, P.C., who shall be responsible for them, for the conduct of the cause of JOSHUA RHETT HARRIS, ESQ; and
5. not be designated as trial counsel and must be accompanied by a member of the New Jersey bar for all proceedings, unless specifically waived by the Court.

IT IS FURTHER ORDERED that JOSHUA RHETT HARRIS, ESQ., shall make payment of all fees due to the State of New Jersey within 30 days of the entry of the pro hac vice Order allowing for admission and as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2, and 1:28B-1(e).

IT IS FURTHER ORDERED that *pro hac vice* admission in the State of New Jersey shall automatically terminate for failure to make the initial payment required by R. 1:20-1(b), R. 1:28-1, and R. 1:28-2.

IT IS FURTHER ORDERED that service of this Order shall be deemed effectuated upon all parties upon its upload to e-Courts. Pursuant to Rule 1:5-1(a), movant shall serve a copy of this Order on all parties not served electronically within seven (7) days of the date of this Order.
