
1. abide by the Rules of the Court of the State of New Jersey, including all disciplinary rules;

3. notify the Court immediately of any matter effecting his standing before this Court; and
4. have all pleadings, briefs and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Sanders Viener Grossman, L.L.P., who shall be responsible for the conduct of Randi A. Kassan, Esquire, and it is further

**ORDERED** that Randi A. Kassan, Esquire shall each make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b) and 1:28b(e) and it is further

**ORDERED** that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further
