IT IS ON THIS 29 day of Aug, 2013



3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of Aylstock, Witkin, Kreis & Overholtz who shall be responsible for the conduct of Kimberly R. Wilson, Esq., and it is further
