ORDER GRANTING ADMISSION PRO HAC VICE

THIS MATTER having been brought before the Court by Andrew J. D'Arcy, Esq., of the law firm of D'Arcy Johnson Day, P.C., on a Motion for an Order granting admission pro hac vice to Robert Partain, an associate of Robinson Calcagnie Robinson Shapiro Davis, Inc. and a member of the Bar of the State of California, to act as counsel to plaintiffs; and the Court having read the moving papers and the opposition thereto, if any; and having considered the arguments of counsel; and for good cause shown;

ORDERED that during the term of his admission pro hac vice, Robert Partain shall:

1) abide by the Rules Governing the Courts of the State of New Jersey as adopted by the Supreme Court, including all disciplinary rules, R. 1:20-1 and R. 1:28-2;

2) consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him or his firm that may arise out of his participation in this matter;

3) notify this Court immediately of any matter affecting his standing at the bar of any other court; and

4) have all pleadings, briefs and other papers filed with the Court signed by an attorney of the firm D'Arcy Johnson Day, P.C. authorized to practice law in this State, who shall be held responsible for them and for the conduct of the cause and of the admitted attorney therein; and it is further
